ANDREAS ROAD, SOQUEL DRIVE, SOQUEL-SAN JOSE ROAD AND
PINECREST DRIVE COUNTY SERVICE AREA NO. 46

Members of the Board:

The plans, specifications and engineer's estimate for the subject pavement overlay project are now complete and presented here for your consideration and approval. The work provides for the rehabilitation and asphalt concrete overlay of those six county road segments previously approved by your Board for Regional Surface Transportation Program grant funding, and one County Service Area (CSA).


The engineer's estimate for this combined work is \$944,212 of which \$69,055 would be funded through CSA No. 46. Sufficient funding for the project will be available in the 2000/2001 road budget and the Pinecrest Drive CSA No.46 budget, contingent upon the Board's approval of said budgets.

It is therefore recommended that the Board of Supervisors take the following action:

1. Approve the plans, specifications, and engineer's estimate and authorize calling for bids for the 2000/2001 Countywide Overlay Program.
2. Set the bid opening for 10:45 A.M. on August 1, 2000.

3. Direct the Clerk of the Board to advertise a Notice to Contractors for a ten-day period beginning July 2, 2000, in accordance with the provisions of Public Contract Code Section 20392.



Sealed proposals shall be delivered to the Director of Public Works of Santa Cruz County, Room 410, Governmental Center, no later than 10:30 a.m., August 1, 2000 and at 10:45 a.m. or soon after, they will be publicly opened and read, in the Supervisors' Hearing Room, 701 Ocean Street, Santa Cruz, California, for construction on the referenced Public Works project in accordance with the specifications therefor, to which special reference is made, as follows:

2000/2001 COUNTY WIDE ASPHALT CONCRETE OVERLAY PROGRAM

**BEAR CREEK ROAD, EMPIRE GRADE ROAD,
FREEDOM BOULEVARD, PINECREST DRIVE (CSA 46),
SAN ANDREAS ROAD, SOQUEL DRIVE,
SOQUEL-SAN JOSE ROAD**

The work to be done consists in general of repairing and resurfacing sections of various County roads by providing digouts, grinding of asphalt pavement, placement of pavement reinforcing fabric, asphalt concrete pavement overlay, striping, and adjustment of surface utility access structures. Plans, specifications, and proposal forms for bidding this project can only be obtained at the office of the Director of Public Works, Room 410, 701 Ocean Street, Santa Cruz, California. No deposit is required. The successful bidder shall furnish a payment bond and a performance bond. The contractor shall possess a Class A license at the time this contract is awarded. The Department of Public Works hereby notifies all bidders that it will affirmatively insure that in any contract entered into pursuant to this advertisement, minority business enterprises will be afforded full opportunity to submit bids and will not be discriminated against on the grounds of race, color or national origin in consideration for an award. Pursuant to Section 1773 of the Labor Code, the general prevailing rate of wages in the County has been determined by the Director of the Department of Industrial Relations, and such prevailing rate of wages is listed in the State of California, Business and Transportation Agency, Department of Transportation publication entitled 'General Prevailing Wage Rates', current edition, on file in the office of the Director of Public Works.
