CONTRACT EXTENSION AMENDMENTS

Dear Members of the Board:

The General Services Department has two contracts for professional services for projects that are currently underway. The first contract, with Fehr and Peers Associates, Inc., is for engineering services pertaining to project recommendations for improving traffic and pedestrian circulation at the Emeline Campus (Project Q45003). The second contract is with the Criminal Justice Research Foundation for their project and grant management services related to the Main Jail Security Upgrade Phase 1 B (Project Q17150).

The agreement with Fehr and Peers Associates, Inc. is recommended for extension from June 30, 2000 to October 21, 2000 in order to complete the remaining work on this initial project development phase. The agreement with the Criminal Justice Research Foundation is recommended for extension from September 1, 2000 to March 18, 2001, which will allow for the completion of project construction and for the Board of Corrections' grant administrative deadlines. All other terms and conditions of each agreement will remain the same.

It is therefore RECOMMENDED that your Board:

1. Approve the contract amendment with Fehr and Peers Associates Inc. (Contract CO2039) extending the contract's ending date to October 21, 2000; and,
2. Approve the contract amendment with the Criminal Justice Research Foundation (Contract CO1 706) extending the contract's ending date to March 18, 2001.
