SUBJECT: Proposed Ordinance Amending Sections 2.42.020 and 2.42.030 of the County Arts Commission Ordinance

Dear Members of the Board:

On March 18, 1997, upon recommendation from the Jerry Allen, Percent for the Arts Report, and members of the County Arts Commission, your Board amended the County's Art Commission ordinance to increase the number of Commissioners from 5 to 10. The rationale for increasing the number of Commissioners was to provide the opportunity to better represent our diverse community.

Since the ordinance was amended to increase the number of Commissioners from 5 to 10 there has been a serious problem with the Commission being able to field a quorum (see exhibit A). It is the Commissions' belief that the larger number of Commissioners reduced the commitment of each Commissioner to attend meetings and thus several meetings each year were canceled due to lack of a quorum. Upon review of the number of times the Arts Commission did not meet for lack of a quorum, as compared to when there were only five Commissioners, the Commission has requested that your Board amend the Arts Commission ordinance to read that there shall be 5 Arts Commissioners, one from each district. Since there currently are 8 seated Commissioners, the Arts Commission suggests that the reduction in the number of Commissioners be accomplished by attrition. The number constituting a quorum would reflect half plus one of the seated Commission members until the goal of 5 Commissioners, one from each district, is achieved.

It is therefore RECOMMENDED that your Board:

- 1. Approve the attached ordinance in concept; and
- 2. Direct the Clerk of the Board to publish the attached Notice of Intention to Adopt Ordinance summarizing the proposed ordinance; and
- 3. Direct that the proposed ordinance be returned to the Board for final consideration on August 8, 2000.

ORDINANCE AMENDING SECTION 2.42.020 TO THE SANTA CRUZ COUNTY CODE RELATING TO ARTS COMMISSION MEMBERSHIP.

The Board of Supervisors of the County of Santa Cruz ordains as follows:

SECTION I

Section 2.42.020 of the Santa Cruz County Code is hereby amended to read as follows:

2.42.020 Membership

- A. The commission shall consist of **ten five** members, residents of Santa Cruz County, appointed by the board of supervisors. Each supervisor shall nominate **two** one persons to serve on the commission. Such nominees may, but shall not be required to, reside within the nominating supervisor's district.
- B. Notwithstanding the foregoing provisions of subsection A which specify a commission consisting of five members, all the members of the commission serving on the date of adoption of this subsection may continue to serve as members of the commission until the expiration of their current term.
