SUBJECT: TREMBLEY PUMP STATION REPLACEMENT

Members of the Board:

The plans, specifications and engineer's estimate for the subject project are complete and presented here for your consideration and approval. The work provides for upgrades to this station including new pumps, controls, and a standby engine to provide emergency power.

The engineer's estimate for this project is \$165,000, not including contingencies and administration. Funding for this project is included in the 2000/2001 Expansion/Construction budget.

It is therefore recommended that the Board of Directors take the following action:

- 1. Approve the plans, specifications, and engineer's estimate for the Trembley Pump Station replacement and authorize calling for bids.
- 2. Set the bid opening for 10:45 a.m. on September 19, 2000.

3. Direct the Clerk of the Board to advertise a "Notice to Contractors" for a 10-day period beginning August 13, 2000, in accordance with the provisions of Public Contract Code Section 20392.

Bids are required for the entire work described herein. The work to be done consists, in general, of abandoning the existing Trembley pump station and replacing it with a new, skid mount pump station complete with all pumps, motors, controls, plumbing, ventilation, site landscaping and standby power.

The successful bidder shall furnish a payment bond and a performance bond.
