2000/2001 COUNTY WIDE ASPHALT CONCRETE OVERLAY PROJECT

AWARD OF CONTRACT

Members of the Board:

On August 1, 2000, the Board of Supervisors received two bids for the County Wide Asphalt Concrete Overlay Project, and both bids were found to be in order. The engineer's estimate was \$955,000, and the low bid was received from Granite Construction Company of Watsonville in the amount of \$922,922. Funds for this project, including contingencies and administration, are available in the 2000/2001 Road Program and the funding set aside for this purpose by County Service Area Number 46 (Pinecrest Drive).

It is therefore recommended that the Board of Supervisors take the following action:

- 1. Accept the low bid of Granite Construction Company in the amount of \$922,922 and authorize award of the contract.
- 2. Authorize the Director of Public Works to sign the contract on behalf of the County.
