- 2. Occurrence: While confined in solitary, I heard one officer say "I'm going to kick your ass" and then three correctional officers attacked me, grabbed me by the hair, repeatedly smashed my head against the cement wall, and then dragged me down the corridor by my hair. They additionally have withheld food from me and even though it is freezing cold, they only give me one thin blanket. This occurred on January 29; 2000, at Santa Cruz County Jail.
- 3. **Description of Indebtedness:** I suffered severe physical injuries to my wrists, neck and head and suffered severe fear, trauma and emotional distress. I need medical help to treat these injuries and the emotional stress.
- 4. Names of public employees causing injury: Correctional Officers Zamora, Haines and one other unidentified officer.
- 5. Amount claimed now......\$ 100,000.00 Estimated future loss......\$ unknown
- 6. **Basis for Computations:** Severe injuries to wrists and neck, severe emotional distress and punitive damages. Pain and suffering.
- 7. Court of Jurisdiction: Superior Court
