### RESOLUTION FIXING 2000-2001 TAX RATES

WHEREAS, the debt service funds of all taxing entities in the County of Santa Cruz have been calculated as to their tax needs for the 2000-2001 year and the respective rates are shown on Exhibit A; and

WHEREAS, the general rate for all taxing entities' operations as allowed under the Constitution is reflected on Exhibit A; and

WHEREAS, the last day for fixing said rates for the 2000-2001 fiscal year is not to extend beyond September 1, 2000;

NOW, THEREFORE, BE IT RESOLVED AND ORDERED that said Board of Supervisors does hereby fix and levy the rates of the county and district taxes pursuant to law and statutes in such cases provided as set forth in Exhibit A attached hereto and by reference made a part hereof.

BE IT FURTHER RESOLVED AND ORDERED that the said Board of Supervisors does hereby fix the allowance for unsecured delinquency to be used in computing the tax rates for the county and special district purposes at the 1999-2000 actual collection experience.
