**Resolution Appointing Thomas L. Bolich as  
Director of Public Works and County Surveyor**

Dear Members of the Board:

It is with great pleasure that I present the attached proposed resolution to appoint Thomas L. Bolich as Director of Public Works and Surveyor for the County of Santa Cruz. I am also recommending that your Board schedule a required public hearing to consider the appointment of Mr. Bolich as the County Road Commissioner on September 12, 2000. State law requires that the appointment of the Road Commissioner can only be made after the Board holds a noticed public hearing on the matter. Therefore, the item before you today recommends appointment of the Public Works Director and Surveyor and requests that your Board schedule the required public hearing to consider the qualifications of Mr. Bolich for appointment as Road Commissioner. In the interim, Mr. Bolich will continue to serve as Acting Road Commissioner. In Santa Cruz, the Director of Public Works also includes the statutory duties of the Surveyor and Road Commissioner.

As Board Members know, Tom has worked for the County for almost 30 years and has served in every division of the department including 20 years in administration and management. Tom Bolich is uniquely qualified to serve in this capacity and I am confident he will do an excellent job on behalf of the residents of the County of Santa Cruz.


It is therefore recommended that your Board adopt the attached resolution appointing Thomas L. Bolich as Director of Public Works and Surveyor and

WHEREAS, Section 161 of the Personnel Regulations including subsection GI(h) set forth the guidelines for appointments and setting salaries for County employees.

NOW, THEREFORE, BE IT RESOLVED AND ORDERED that the Santa Cruz County Board of Supervisors appoints Tom Bolich to the position of Director of Public Works and Surveyor, Step 5, effective September 2, 2000.


