SUBJECT: 2000/200 1 COUNTY WIDE PAVEMENT **DIGOUT** PROJECT

Members of the Board:

The specifications and engineer's estimate for the 2000/2001 County Wide Pavement Digout Project are complete and presented here for your consideration and approval. The project provides for preparing roads for next summer's seal coat project through digouts and patching.

The engineer's estimate for this project is \$750,000 not including contingencies and administration. Sufficient funds are available in the County road budget to cover this expenditure.

It is therefore recommended that the Board of Supervisors take the following action:

- 1. Approve the specifications and engineer's estimate and authorize calling for bids.
- 2. Set bid opening for 10:45 a.m. on September 19, 2000.
- 3. Direct the Clerk of the Board to advertise a Notice to Contractors for a ten day period beginning August 27, 2000, in accordance with provisions of the Public Contract Code Section 20392.

Sealed proposals shall be delivered to the Director of Public Works of Santa Cruz County, Room 410, Governmental Center, no later than **10:30 a.m., SEPTEMBER 19,** 2000, and at **10:45** a.m. or soon after, they will be publicly opened and read, in the Supervisors' Hearing Room, 701 Ocean Street, Santa Cruz, California, for construction on County roads in accordance with the specifications therefor, to which special reference is made, as follows:

2000/2001 COUNTY WIDE PAVEMENT DIGOUT PROJECT

The work to be done consists, in general, of preparing damaged areas of County roads for seal coating through digouts as specified on the digout location list and construction detail in these special provisions.

Plans, specifications, and proposal forms for bidding this project can only be obtained at the office of the Director of Public Works, Room 410, 701 Ocean Street, Santa Cruz, California. No deposit is required.

The successful bidder shall furnish a payment bond and a performance bond.

The contractor shall possess a Class A license at the time that this contract is awarded.

The Department of Public Works hereby notifies all bidders that it will affirmatively insure that in any contract entered into pursuant to this advertisement, minority business enterprises will be afforded full opportunity to submit bids and will not be discriminated against on the grounds of race, color or national origin in consideration for an award.

Pursuant to Section 1773 of the Labor Code, the general prevailing rate of wages in the District has been determined by the Director of the Department of Industrial Relations, and such prevailing rate of wages is listed in the State of California, Business and Transportation Agency, Department of Transportation's publication entitled General Prevailing Wage Rates, current edition, on file in the office of the Director of Public Works.
