Members of the Board:

On August 1, 2000, the Board of Supervisors received two bids for the subject project. Both bids were found to be in order. The engineer's estimate was \$214,385.00. The low bidder was Bugler Construction of Fremont, in the amount of \$208,920.00.

Seismic retrofit work is 100% funded by the State Department of Transportation, and sufficient funds are available in the approved 2000/2001 Road Program to cover this expenditure plus contingencies and administration.

It is therefore recommended that the Board of Supervisors take the following action:

1. Accept the low bid of Bugler Construction of Fremont in the amount of \$ 208,920.00 and authorize the award of contract.

2. Authorize the Director of Public Works to sign said contract on behalf of the County of Santa Cruz.
