Dear Supervisor Almquist:

Pursuant to State Housing Law, AMBAG is mandated to prepare and adopt a Regional Housing Needs Plan for the Monterey and Santa Cruz counties area by June 30, 2001. To assist us in this effort, the AMBAG Board of Directors is forming a technical advisory committee. The committee will be comprised of city and county representatives and be augmented by other housing advocates, in an ex-officio capacity.

We are requesting that you designate an individual, and an alternate member if desired, to the advisory committee. The purpose of the committee would be to advise the AMBAG Board of Directors on a methodology for distributing the regional/county-wide need to the city and county jurisdictions and on other issues pertaining to the preparation of this Regional Housing Needs Plan.
