SUBJECT: SIXTH ANNUAL MONTE FOUNDATION FIREWORKS SHOW, ROAD CLOSURE

Members of the Board:

The Rudolph F. Monte Foundation (Monte Foundation) is sponsoring its sixth Annual Monte Foundation Fireworks Show at Seacliff State Beach on Saturday, October 14, 2000. In conjunction with the event, and in cooperation with Public Works, the Sheriffs Department, the California Highway Patrol, and various other agencies, the Monte Foundation is requesting road closures for traffic and crowd control.

As in the past, the popularity of this show makes it necessary to close portions of State Park Drive, Santa Cruz Avenue, Broadway, El Camino Del Mar, and Seacliff Drive between the hours of 12:00 noon and 10:00 p.m. An improved procedure will be employed this year to facilitate access for local residents impacted by these closures.

It is therefore recommended that the Board of Supervisors take the following action:

Approve the road closures and sixth Annual Monte Foundation Fireworks Show, subject to conditions on the attached road closure permit.

2. Direct the Public Works Department to issue the road closure permit.

SUBJECT: SIXTH ANNUAL MONTE FOUNDATION FIREWORKS SHOW

ROAD CLOSURE PERMIT

Dear Mr. Monte:

Pursuant to the Board of Supervisors action dated September 12, 2000, a permit to close portions of State Park Drive, **Seacliff** Drive, Broadway, and Santa Cruz Avenue, for the Monte Foundation Annual Fireworks Show at **Seacliff** State Beach, between the hours of 12:00 noon and 10:00 p.m., Saturday, October 14, 2000, is granted with the following conditions:

- I. Uniformed law officers and road closure barricades/fencing, with detour signs, shall be placed at the following locations:
 - a. State Park Drive south of Center Avenue
 - b. Santa Cruz Avenue west of Broadway
 - c. Broadway south of Santa Cruz Avenue
 - d. El Camino Del Mar south of Santa Cruz Avenue
 - e. Seacliff Drive south of Santa Cruz Avenue
- 2. To safely restrict the cliff area and prevent pedestrian access, temporary safety fencing shall be placed along the curb line of **Seacliff** Drive adjacent to the cliff, Temporary safety fencing and "no parking" signs may be installed after 10:00 p.m. of the previous evening.
- 3. To prevent parking and to accommodate safe bus shuttle service, "no parking" signs shall be placed along the east side of Cabrillo College Drive, south of Soquel Drive, after 10:00 p.m. of the previous evening.

- 4. The permittee shall provide, at their own expense, **sufficient** signs, barricades, cones, flagging, fencing and personnel to safely and clearly mark the closure areas.
- 5. Control of all traffic and placement of all traffic control devices shall be coordinated with the California Highway Patrol.
- 6. Access shall be provided to emergency vehicles.
- 7. Immediately following the event, a clean-up shall be made of the entire closure.
- 8. This permit does not grant permission to use private property. The permittee shall be responsible for all arrangements in the use of private property and beach areas.
- 9. The Monte Foundation shall exonerate, indemnify, defend, and hold harmless, the County of Santa Cruz, including without limitation, its officers, agents, employees, and volunteers from and against any and all claims, demands, losses, damages, defense costs, or liability of any kind or nature which County may sustain or incur or which may be imposed upon it for injury to or death of persons, or damage to property as a result of, arising out of, or in any manner connected with the performance under the terms of this permit, excepting any liability arising out of the sole negligence of the County. Such indemnification includes any damage to the person(s), or property(ies) of the County of Santa Cruz and third persons.
- 10. The Monte Foundation, at its sole cost and expense, for the full term of this permit (and any extensions thereof), shall obtain and maintain at minimum compliance with all of the following insurance coverage(s) and requirements. Such insurance coverage shall be primary coverage as respects County and any insurance or self-insurance maintained by County shall be excess of the Monte Foundation insurance coverage and shall not contribute to it.
- 11. Comprehensive or Commercial General Liability Insurance coverage in the minimum amount of \$1 ,000,000.00 combined single limit, including coverage for: (a) bodily injury, (b) personal injury, (c) broad form property damage, (d) contractual liability, and (e) cross-liability.
- 12. All required Comprehensive or Commercial General Liability Insurance shall be endorsed to contain the following clause:
 - "The County of Santa Cruz, its officials, employees, agents and volunteers are added as an additional insured as respects the operations and activities of, or on behalf of, the named insured performed under permit with the County of Santa Cruz."

13. All required insurance policies shall be endorsed to contain the following clause: 0.40

"This insurance shall not be canceled until after thirty (30) days prior written notice has been given to:

- 14. The Monte Foundation agrees to provide its insurance broker(s) with a **full** copy of these insurance provisions.
- 15. A CERTIFICATE OF INSURANCE(S) MUST BE FILED WITH THE DEPARTMENT OF PUBLIC WORKS AT LEAST TEN (10) DAYS PRIOR TO THE EVENT OR THIS PERMIT WILL BE CANCELED. All Certificates of Insurance shall be delivered or sent to:

- 16. A Public Notice shall be placed in a newspaper of general circulation giving the time, date, and name of road closures.
- 17. The permittee shall notify each affected business and resident of the road closures, giving time and duration of closures at least ten (10) days prior to the event.
- 18. All local emergency services and the Santa Cruz Metropolitan Transit District are to be notified by the permittee of the event and road closures.
