RE: Appointment of Road Commissioner

Dear Members of the Board:

On August 15, 2000, your Board appointed Thomas L. Bolich as County Public Works Director and Surveyor. Mr. Bolich is also currently serving as Road Commissioner, which is a function of the position of the Public Works Director. The duties of the Road Commissioner are found in the Streets and Highways Code at section 2009. In order to be appointed to this post, the Board of Supervisors must conduct a public hearing to consider the qualifications of a candidate. The public hearing must be noticed in the local newspaper and posted at the County Courthouse. The notices have been made by the Clerk of the Board and today is the date that the public hearing is to be held.

As you have been previously advised, Mr. Bolich is a registered civil engineer with more than 30 years of progressively responsible experience in the field. He has worked for the County since 1970 beginning as an entry level engineer and earning several promotions to eventually become an Assistant Director in the department in 1990. He is well suited to serve as the County's Road Commissioner and I offer my highest recommendation of Mr. Bolich to you.
