Members of the Board:

Attached is Program Supplement Number 022-M to the County-State Agreement No. 05-5936 with an authorizing County resolution. This program supplement allocates a combined total of \$75,000 for the preliminary engineering of the subject bridge replacement project which will allow us to restore this critical south county roadway.

It is therefore recommended that the Board of Supervisors take the following action:



## SPECIAL COVENANTS OR REMARKS

1. The Local Agency agrees the payment of Federal funds will be limited to the amounts approved by the Federal Highway Administration in the Federal-Aid Project Agreement (PR-2)/Detail Estimate, or its modification (PR-2A) or the FNM-76, and accepts any increases in Local Agency Funds as shown on the Finance or Bid Letter or its modification as prepared by the Office of Local Programs Project Implementation.
2. The Local Agency will advertise, award and administer this project in accordance with the current Local Assistance Procedures Manual.
3. This agreement supplements the Local Agency-State Master Agreement Federal-Aid projects, with the understanding that all provisions Transportation Equity Act (TEA-21) apply.
4. This Program Supplement will be revised at a later date to include other phases of work.
5. All maintenance, involving the physical condition and the operation of the improvements, referred to in Article III MAINTENANCE of the aforementioned Master Agreement will be the responsibility of the Local Agency and shall be performed at regular intervals or as required for efficient operation of the completed improvements.
