

SUBJECT: FEDERAL GRANT FUNDING FOR WASTE REDUCTION

Members of the Board:

As your Board may recall, one of the priorities of this year's work plan for the Department of Public Works Solid Waste section is diversion of food waste from landfill diversion. According to the County's recently completed solid waste disposal characterization study, food waste represents about 30 percent of the refuse still going to the landfill. Last month, your Board approved an independent contractor agreement with Karin Grobe of Organic **Recyclers** Anonymous (**ORA**) to work on various food waste diversion projects. This contract includes a ten percent time allocation for public outreach work for vermicomposting (worm cornposting) as a means to encourage county residents to produce less waste requiring landfill disposal.

Public Works would like to augment the vermicomposting public outreach portion of the **ORA** contract to give additional emphasis on this method of residential waste reduction. This additional work would involve the training of a core group of volunteer "Master **Vermicomposters**" who in turn would offer public workshops on how to compost at home using worms. Public Works has recently received an opportunity to partially offset the cost of this additional work which we believe is worth pursuing.

Public Works has been contacted by the Skills Center, Inc., of Santa **Cruz** informing our department that the Skills Center had been awarded a grant from the U.S. Environmental Protection Agency (EPA), Region IX in the amount of \$5,000 for promotion of vermicomposting and that the Skills Center, however, would not be able to accept the award for various reasons. Given the County's interest in this type of promotion, it was suggested that the grant award be transferred from the Skills Center to the County. The transfer is agreeable to the EPA and they are requesting authorization from the Board of Supervisors for Public Works to submit a grant application to effect the transfer.

The grant will help fund the training of the "Master Vermicomposters" and the acquisition of related training materials. Total cost for this additional work is \$13,055 of which \$5,000 will be grant funded, Public Works is recommending that this project be performed through an amendment to the recently approved independent contractor agreement with Karin Grobe of **ORA**.

A copy of the proposed EPA grant application, including the project scope of work and budget, is included with this letter for your Board's information. An amendment to agreement for Karin Grobe in the increased amount of \$13,055 for a not-to-exceed amount of \$74,055 is also attached for your Board's consideration. Sufficient funds are available in the **Refuse** Budget for this expense.

It is therefore recommended that your Board take the following actions:

- 1. Authorize the Director of Public Works to submit an Application for federal assistance/environmental education grant to the U.S. EPA, Region IX in the amount of \$5,000 for vermicomposting public education and sign all necessary documents associated with the application.
- **2.** Approve amendment to agreement with Karin Grobe in the increased amount of \$13,055 for a not-to-exceed amount of \$74,055 to provide for consultant labor and direct expenses to carry out the vermicomposting public education project and other food waste diversion activities.
- **3.** Authorize the Director of Public Works to sign the agreement on behalf of the County.

SCOPE OF WORK ADDENDUM

This addendum describes additional duties to be performed under County of Santa Cruz Independent Contractor's Agreement # COO2 186.

MASTER VERMICOMPOSTER TRIANING AND PUBLIC OUTREACH

CONTRACTOR will:

- 1) Organize and conduct training sessions for volunteer Master Vermicomposters
 - a) recruit volunteers
 - b) secure training sites
 - c) develop training curricula
 - d) prepare and assemble training materials; supply trainees as needed
 - e) arrange for guest speakers
- 2) Manage Master Vermicomposter Volunteer Outreach Activities
 - a) organize outreach program for workshops, schools, worksites
 - b) obtain volunteer commitments and track hours
 - c) provide material and technical support to volunteers
- 3) Evaluate Project
 - a) Design survey and analyze results
 - b) Meet with volunteers to assess outreach results
- 4) Prepare Project Reports
 - a) prepare reports required by EPA grant
 - b) submit reports to County of Santa Cruz as requested

Activities will be consistent with and fulfill obligations of U.S. EPA Environmental Education Grant for Master Vermicomposter Training and Public Outreach.

Work Plan

7. Project Summary

a. Organization and Partners

Through a series of trainings, we will educate non-formal educators about vermicomposting. These educators will then be Master Vermicomposters, and will take the knowledge and disseminate it to the community at Vermicomposting Workshops.

Santa Cruz County Department of Public Works is charged with developing and implementing programs to reduce landfilling of waste and to meet the state 50% diversion mandate. Santa Cruz County Department of Public Works will take over the Master Vermicomposter grant awarded to the Skills Center. Dan deGrassi, County of Santa Cruz, will be contract manager and contact person for the grant.

Karin Grobe, Organic Recyclers Anonymous, will conduct the trainings for the Master Vermicomposters, provide the master copy of the course notebook, facilitate public outreach including workshops and on-site worm bins, design the surveys for project evaluation and facilitate the Evaluation Meeting..

Kelly Slocum is a Vermiculture specialist for Clark County, Washington and Associate Editor for Worm Digest. Ms. Slocum will be a guest speaker at one of the Master Vermicomposting Trainings. She will also assist by providing curriculum materials for the Trainings.

Ecology Action is a non-profit organization that has over eight years experience in conducting Master Composter Trainings and Home Compost Workshops in Santa Cruz County. Ecology Action will allow use of their Education Display Boards and will provide curriculum for the Trainings.

b. Summary Statement

Vermicomposting is the practice of using worms to transform food waste into a nutrient-rich finished product called vermicompost. Vermicomposting, practiced at schools, work sites, and homes, helps to divert food waste to beneficial use, saving valuable landfill space. We will conduct a training for 20 Master Vermicomposters. These Master Vermicomposters will be required to spend volunteer hours (1) conducting vermicomposting workshops to educate Santa Cruz County residents, students, teachers and business managers on how to use vermicomposting to divert food waste from the landfill, (2) setting up and maintaining worm composting bins at schools and providing associated curriculum support, and (3) setting up and maintaining worm bins at work sites, and providing associated educational outreach.

c. Educational Priority

Teaching Skills. We will educate nonformal educators about waste management and vermicomposting in order to improve their environmental education skills.

d. Delivery Method.

Through a series of trainings, we will educate non-formal educators about vermicomposting. These educators will then be Master Vermicomposters, and will take the knowledge and disseminate it to the community by setting up worm bins at schools and works sites and presenting Vermicomposting Workshops.

e. Audience

The target audience includes residents, schools and business owners of Santa Cruz County who are interested in using a vermicomposting bin to divert food scraps from County landfills.

f. costs

The grant will fund the Master Vermicomposter trainings, the production and assembly of the Master Vermicomposter notebooks, the provision of worms and bins for Master



2. Project Description

Vermicomposting is the practice of using worms to transform food waste into a nutrient-rich finished product called vermicompost. Worms are extremely efficient food waste digesting machines that eat over half their body weight in organic matter per day. Vermicomposting, practiced at schools, work sites, and homes, helps to divert food waste to beneficial use, saving valuable landfill space.

Vermicomposting has received much media attention in the recent years, and many members of the community in Santa Cruz County have a high level of interest in vemicomposting. However, at present, there is a lack of knowledge on the "nuts and bolts" of how to start and maintain small, on-site vermicomposting systems for home, school and workplace. Ecology Action, a non-profit organization that has over eight years experience in conducting Master Composter Trainings and Home Compost Workshops in Santa Cruz County, has identified a strong public interest in vermicomposting, and they see a clear need for increased public vermicomposting education within Santa Cruz County.

Master Vermicomposter Trainings

We propose to fill that need by training 20 Master Vermicomposters to educated the public about vermicomposting. Master Vermicomposters will attend a series of five evening or weekend trainings covering:

- Overview of food waste issues for Santa Cruz County and its four incorporated cities.
- On-site vermicomposting in home, school and office as a environmental option for food waste.
- Biology and ecology of the earthworm, with a focus on Eisenia fetida.
- Care and feeding of E. fetida.
- Other creatures commonly found in the worm bin
- Appropriate bins for home, school and office.
- How to set up and maintain a worm bin.
- Troubleshooting problems in the worm bin.

Existing curriculum for the Master Vermicomposter trainings will be utilized. This material will be assembled and organized by Karin Grobe. Much of the material was collected from presentations given by Kelly Slocum at Vermicomposting Conferences held by VermiCo (Best Management Practices for Vermicomposting, Medford, September 1999 and New Horizons in Vermicomposting Conference, Stockton, March 1999). One Master Vermicomposter training will feature Kelly Slocum as a guest speaker.

Master Vermicomposters will be provided with worm bins and a pound of worms to allow them to experience, hands-on, the care and feeding of a worm bin. They will receive a course notebook that will include class notes, which they can review as needed. They will also receive a copy of Worms *Eat My Garbage*, by Mary Applehof. This book covers many aspects of the care and feeding of worms and vermicomposting. By providing course materials and a worm bin to participants we will overcome some of the financial barriers to volunteering that might potentially discourage low-income volunteers.

Master Vermicomposter Volunteer Hours

At the conclusion of the trainings, each Master Vermicomposter will spend 50 volunteer hours (1) conducting Vermicomposting workshops to educate Santa Cruz County residents, students, teachers and business managers on how to use vermicomposting to divert food waste from the landfill, (2) setting up and maintaining worm composting bins at schools and providing associated

curriculum support, and (3) setting up and maintaining worm bins at work sites, and providing associated educational outreach.

The workshops will take place at Farmers' Markets, schools, garden clubs and retail plant nurseries. Organic Recyclers Anonymous will support the workshops by setting up or providing demonstration worm bins and Vermicomposting Education Display Boards. Whenever possible, vermicomposting products will be made available for sale to the public at the workshops. The purpose of the workshops will be to educate the public about the advantages of vermicomposting and how to set up their own worm bin at home, school or the office. We will hold at least 10 workshops during the year of grant funding and have included those workshops in our project budget. Other workshops will be held in following years and are not included in the budget.

Project Goal and Potential Diversion Estimates

Our goal is to increase the practice of vermicomposting in Santa Cruz County. Each person generates 162.2 pounds of food waste per year (1996 U.S. EPA, Washington, D.C. estimate). We estimate that at least half, or 81 .1 pounds of that is generated at home, school or office and can be used for vermicomposting.

We hope to instruct 20 people at each public workshops that will be held by the Master Vermicomposters (200 people total). We hope to reach another 200 people through the school and work site bin demonstrations. We estimate that at least 1/2 of the people that learn about vermicomposting, or 200 people, will become successful vermicomposters. Each vermicomposting system that is set up will serve an average three-person household. Therefore, 600 people will be served by vermicomposting systems that will be set up as a result of the workshops. Approximately 24.45 tons of food waste will be diverted from County landfills each year as a result of the workshops (600 x 81.5]/2000 pounds per ton).

We believe this estimate is conservative, and note that it does not allow for the adoption of vermicomposting by friends and neighbors of the 200 successful vermicomposters and 20 Master Vermicomposters.

Project Benefits

Benefits of the project are far-reaching. Currently, there is no permitted composting facility in the County. A waste composition study that was recently been completed by the County of Santa Cruz indicates that approximately 29% of the residential waste that is currently being landfilled is food waste. If food waste were to be collected, it would need to be transported a relatively long distance to a composting site that accepts food waste. On-site composting avoids the environmental cost of transport to a centralized compost facility, as well as the environmental cost of separate collection and energy-dependent composting systems. Empowering people to vermicompost their own food waste is environmentally preferable and more cost effective than setting up a collection program for centralized composting.

This project will set up what will be, to the best of our knowledge, the first Master Vermicomposter training program in the US. Worms, and composting with worms, have recently received much public attention through articles in newspapers and magazines. This project capitalizes on that attention, and sets up a program that makes it easy for interested members of the public to move ahead with home-based food waste management using worms.

This project will serve as a model for use in other locations to educate residents about how to use worms to turn food scraps into vermicompost. We will share our Master Vermicomposter training tools with other programs as requested.

Proiect Staff

The project will be managed by Karin Grobe, Organic Recyclers Anonymous. Ms. Grobe will be in charge of recruiting volunteers and overseeing promotion and coordination of the workshops. She will conduct Master Vermicomposter trainings and provide the master copy of the course notebook. Ms. Grobe will support Master Vermicomposters who set up worm bins at schools or work sites. She will design the survey for project evaluation and facilitate the Evaluation Meeting

3. Project Evaluation

The success of the workshops will be evaluated by tracking numbers of participants, and asking each workshop participant to complete a brief survey. The survey instrument will measure:

- . Impact of the workshop on the participants knowledge of vermicomposting.
- Impact of the workshop on the participants willingness to use vermicomposting to divert food waste from the landfill.
- Impact of the workshop on the participants actions (i.e., Does participant plan to get worms or a bin?).

The success of the work site and school demonstration worm bins will be evaluated by asking the Master Vermicomposter to submit a one-page write up on how much food was diverted through use of the bin, how many people learned about composting with worms as a result of the demonstration, potential for adoption of vermicomposting by affected group, use of vermicomposting curriculum, etc.

Results of the surveys will be evaluated at an Evaluation Meeting held in May 2001. This meeting will be facilitated by Karin Grobe and will reunite the Master Vermicomposters. They will be informed of the results of the surveys. Discussion of changes that might be made to increase the program's effectiveness will follow, and any action items will be implemented.
