Light Staining Microscope for Sexual Assault Nurse Examiners Program

Dear Members of the Board:

During the fiscal year 2000/01 budget process, your Board approved the Sheriffs Office request to manage the administration and operation of the Sexual Assault Nurse Examiners (SANE) Program. This program was previously administered as part of the Criminal Justice Council.

As you will recall, the program is fully funded by participating agency contributions which finances two specially trained nurse examiners contracted to provide sexual assault examinations on adult and juvenile victims and various operating expenditures for supplies and equipment. The duties further require the examiners to consult with law enforcement concerning exam results, compile and maintain statistical information, research forensic issues in preparation for court testimony and testify in court concerning examinations.

The nurse examiners have identified a much needed piece of equipment, which they would like to purchase with existing appropriations in their operating expense budget. This piece of equipment is a Light Staining Microscope used as part of the medical examination process for the investigation and treatment of victims of sexual assault. The purchase of this piece of equipments will improve the quality and effectiveness of the examinations conducted by the SANE program. The microscope recommended for purchase will cost \$3,200.

It is, therefore, RECOMMENDED, that your Board:

- 1. Approve the purchase of a Light Staining Microscope, Model OS04, for the Sexual Assault Nurse Examiner Program in an amount not-to-exceed \$3,200; and
- 2. Approve transfer of funds in the amount of \$3,200 from the Sheriffs Office budgeted appropriations in operating expenses to fixed assets in order to finance the purchase.
