REQUEST TO ADVERTISE WATSONVILLE COURT WATERLINE & WALKWAY#OOCI-002

Members of the Board:

As part of the 2000/2001 re-budgets for General Services maintenance projects, your Board allocated funds to provide for a licensed contractor to replace approximately 90 ft. of domestic water supply line between the city meter and the courthouse and repair sidewalk and 1,200 sq. ft. of walkway located at 1430 Freedom Blvd., Watsonville. Plans and specifications have been prepared by the Department of General Services. These items and associated documents related to the project must be approved by your Board prior to solicitation of written proposals. Funds are available in Budget Index 333100/3405, Sub-Object G62002. The cost of the project is estimated to be \$18.000.

It is therefore RECOMMENDED that your Board take the following actions:
