SUBJECT: Pinto Lake County Park - Farming Lease Agreement

Dear Members of the Board:

On June 1, 1998, as authorized by your Board, the Parks, Open Space and Cultural Services Department entered into the Pinto Lake County Park - Farming Lease Agreement with Richard Peixoto.

The lease is for use of 25 acres in Pinto Lake County Park for an annual fee of \$15,000. It is being proposed that the lease be amended to reduce the acreage from 25 to 20 acres. The reduction will provide for the removal of farming from some steep areas of the property, reduce erosion and provide a buffer between the farming operation and property owners across the lake.

Mr. Peixoto has agreed to amend the lease from the original 25 acres to 20 acres with a prorated reduction in the lease fee. The annual fee would be reduced from \$15,000 to \$12,000. Payments would still be made on a quarterly basis at the rate of \$3,000 per quarter.

It is therefore RECOMMENDED that your Board authorize the Parks Director to execute the Amendment to the Lease Agreement reducing the farm acreage from 25 to 20 acres and the annual fee from \$15,000 to \$12,000 per year effective December 1, 2000.

AMENDMENT TO LEASE AGREEMENT

The parties hereto agree to amend that certain lease agreement dated June 1, 1998, by and between the COUNTY OF SANTA CRUZ and RICHARD PEIXOTO, by changing the following language in paragraphs:

- Premises. Lessor leases to Lessee and Lessee leases from Lessor the premises located in the 1. County of Santa Cruz, State of California described as annroximately 20 acres of undeveloped land which is part of Pinto Lake County Park. A man delineating; the premises is attached as Exhibit A (Western Half of APN 050-141-11).
- Rent. Effective December 1.2000. Lessee will pay Lessor rent for the use and possession of 3. the premises in the sum of \$12,000 per vear with \$3,000 payable on or before December 1st. and the remainder due in 3 eaual installments of \$3,000 each, savable on March 1st June 1st and Sentember 1st, Payments shall be made to the County Parks Denartment, 979 17th Avenue. Santa Cruz. CA 95062.

All other provisions of the Lease Agreement shall remain the same.


