RE: NOTICE OF COMPLETION FOR BONNY DOON REPLACEMENT FIRE STATION CONTRACT #CO 81826

Members of the Board:

On September 15, 2000, the Watsonville Construction Company, Inc. completed the Bonny Doon Replacement Fire Station project. The original bid amount was \$484,000. Six approved change orders were issued which increased the contract by \$46,295 and provided: (1) soil inspection services; (2) steel/concrete inspection services; (3) trenching for underground electrical work; (4) tree removal; (5) the addition of a concrete apron; and, (6) a lighting upgrade with additional electrical breaker and pump installation. One additional approved change order was issued for Liquidated Damages due to time overruns that decreased the final contract amount by \$15,600. The total construction cost for this project is \$514,695.

It is therefore RECOMMENDED that your Board take the following actions:

- 1) Accept the project as completed;
- 2) Approve the final cost of \$514,695;
- 3) Authorize the Clerk of the Board to file the executed Notice of Completion with the office of the County Recorder, a copy of which is attached.
