ACCEPTANCE INTO THE COUNTY-MAINTAINED ROAD SYSTEM

Members of the Board:

On September 28, 1998, the parcel map for MLD 92-0975 was recorded. The developer of the project completed construction of the required improvements on February 29, 2000. The Public Works Department inspected the constructed improvements and found that they are complete and acceptable.

In order for the County to assume maintenance responsibilities for Chanticleer Avenue, Parcel "A," it will be necessary for your Board to formally accept Parcel "A" along the northeast side of Chanticleer Avenue into the County Maintained Road System,

It is therefore recommended that the Board of Supervisors adopt the attached resolution accepting Parcel "A" along the northeast side of Chanticleer Avenue into the County Maintained Road System.
