The subject project was completed on August 31, 2000. The contractor was Earthworks of Santa Cruz.

The original bid price was \$17,150.00 and total construction cost is \$15,887.50. The decrease was due to no extra work being required and slightly fewer **digouts** than anticipated. A summary of final costs is attached for your information.

It is therefore recommended that the Board of Supervisors take the following action:

1. Accept the improvements and approve the final cost.
2. Authorize the Clerk of the Board to file the Notice of Completion, a copy of which is attached.


