RE: PROPOSED NEW MULTI-WAY STOP SIGNS

Dear Members of the Board:

The Public Works Department has been working with the Sheriff's Department and residents from the Mesa Verde area off of Green Valley Road to promote traffic safety improvements in their neighborhood. It has become apparent, however, that additional traffic control measures are needed. Therefore, I am recommending the installation of four new multi-way stop sign locations for the Mesa Verde neighborhood. Three of the locations are proposed on Mark Avenue which parallels Green The other location is the mid-way point on Jolon Valley Road. Although none of the proposed stop signs meet stop sign Drive. warrants from the State Traffic Manual, I believe that overall safety will be enhanced by this proposal. A map of the proposed stop sign locations is attached for review.

It is therefore recommended that the Board of Supervisors consider adoption of the attached ordinance in concept for the installation of the proposed multi-way stop signs, and place the ordinance on the next available agenda for final adoption.


