APPROVE INCREASE TO CONTRACT #CO 92107 WITH KASE PACIFIC CONSTRUCTION FOR REPAIRS RELATED TO WATER DAMAGE AT 1000 EMELINE

Dear Members of the Board:

During the 2000/2001 Budget Hearings your Board approved and authorized funding for the General Services Department to proceed with repairs to the plumbing system and the water damage to 1000 Emeline. The repair work was to be coordinated with the renovation project in progress.

The construction company under contract with the County for the renovation project is Kase Pacific Construction. In addition to the renovation project, the contractor is coordinating and overseeing the water damage repairs, including replacement of the plumbing system. It is necessary to increase the original renovation contract with Kase Pacific Construction for expenditures in the amount of \$100,000 to provide payment for costs associated with the water damage repairs.

It is therefore RECOMMENDED that your Board:

- 1. Authorize an amendment to the agreement (CO 92107) with Kase Pacific Construction to increase the contract in the amount of \$100,000 for costs associated with replacement of the plumbing system and major repairs resulting from water damage; and
- 2. Approve the ADM 29 increasing the contract (CO 92107) encumberance in the amount of \$100,000 from funds available in 191060-6610 (Q30003).
