SUBJECT: GRAHAM HILL ROAD LONGITUDINAL GROOVING PROJECT

Members of the Board:

The special provisions and engineer's estimate for the Graham Hill Road Longitudinal Grooving Project are complete and presented here for your consideration and approval. This project is designed to improve the riding characteristics of a critical 550 meter (1,700 ft.) section of Graham Hill Road south of Roaring Camp. As your Board is aware, the Public Works Department is also pursuing the larger Graham Hill Road Improvement Project in this same project corridor area, which is scheduled for the 2002/2003 construction year. In the interim, however, the Longitudinal Grooving Project is expected to greatly improve the operation of this critical segment of the roadway and enhance motorists' safety until such time as the larger Graham Hill Road Improvement Project can be completed.

The engineer's estimate for the subject project is \$25,000, not including contingencies and administration. This estimate includes \$3,000 set aside for the cost of potential weather delays. Sufficient funding for this project is available in the approved 2000/2001 Road Fund.

It is therefore recommended that the Board of Supervisors take the following action:

- 1. Approve the special provisions and engineer's estimate, and authorize calling for bids.
- 2. Set bid opening for 10:45 a.m. on November 14, 2000.

3. Direct the Clerk of the Board to advertise a Notice to Contractors for a **ten**-day period beginning October 29, 2000, in accordance with provisions of the Public Contract Code Section 20392.

Sealed proposals shall be delivered to the Director of Public Works of Santa Cruz County, Room 410, Governmental Center, no later than **10:30 a.m. November 14, 2000**, and at **10:45** a.m. or soon after, they will be publicly opened and read, in the Supervisors' Hearing Room, 701 Ocean Street, Santa Cruz, California, for construction on Graham Hill Road in accordance with the specifications therefor, to which special reference is made, as follows:

LONGITUDINAL GROOVING

The work to be done consists, in general, of longitudinal grooving on Graham Hill Road for 550 meters to the limits indicated on the plans.

Plans, specifications, and proposal forms for bidding this project can only be obtained at the office of the Director of Public Works, Room 410, 701 Ocean Street, Santa Cruz, California. No deposit is required.

The successful bidder shall furnish a payment bond and a performance bond.

The contractor shall possess a Class A license at the time that this contract is awarded.

The Department of Public Works hereby notifies all bidders that it will affirmatively insure that in any contract entered into pursuant to this advertisement, minority business enterprises will be afforded full opportunity to submit bids and will not be discriminated against on the grounds of race, color or national origin in consideration for an award.
