NOTICE OF COMPLETION

Dear Members of the Board:

On August 28, 2000, the Planting and Irrigation at Polo Grounds County Park Project was completed. The Contractor for the project was Hastings Landscape Conservation Services. The original bid amount was \$72,984. Construction Change Orders increased construction costs by \$6,429, for a total construction cost of \$79,413.

This project included the installation of an irrigation system for approximately 2 acres of new plant material, including trees, shrubs and bulbs. In addition, the project included the installation of 470 LF of split rail fencing. Contract changes included the installation of six (6) pressure regulators for each valve for individual circuit control, planting soil amendments, and soil preparation for a future 4,300 SF turf expansion area near the intersection of North Polo and South Polo Drives.


