Members of the Board:

The subject project was completed on September 14, 2000. The contractor was West Coast Engineering, of San Martin, CA.

The original bid price was \$450,531.00. Total Construction cost is \$470,074.12. The increase is a result of quantity changes in contract items and an increase in extra work, which was authorized by Contract Change Order No. 3 and approved by your Board on March 7, 2000. A summary of final costs is attached for your information.

Pursuant to the "Agreement with Relation to Water Facilities, License, and Reimbursement" entered into on June 30, 1997, effective as of completion of construction, ownership and maintenance responsibility for the water facilities shall be by the City of Watsonville.

It is therefore recommended that the Board of Supervisors take the following action:

1. Accept the improvements and approve the final cost.
2. Authorize the Clerk of the Board to file the Notice of Completion, a copy of which is attached.

3. Direct the County Recorder to return the original Notice of Completion to the Clerk of the Board.


