Contract Amendment for Construction Services

Dear Members of the Board:

Construction of the Anna Jean Cummings Park, which commenced this June, is about 50% complete. Most of the site grading, utilities, and parking areas are finished. Site concrete, as well as most of the furnishings, play equipment, planting and irrigation, have yet to be installed. Overall, construction has gone quite well, with the job proceeding on time and with high quality workmanship.

The County has contracted directly with Haro Kasunich and Associates for soils and compaction testing in order to verify the construction of the park is following the approved soils report and grading permit conditions. When the contract was approved for these services, the soils engineer was only able to estimate the required work contingent upon the contractors construction schedule. In addition, during construction the scope of work was expanded to include tests for the road improvements on Soquel-San Jose Road, as it was more cost effective and convenient to use the on-site soils engineer.

As a result, it will be necessary at this time to amend the Agency's contract with Haro Kasunich and Associates, the soils engineering firm for the project, in order to provide for an extension of their services. Funds are available in the project budget for this purpose.

It is therefore RECOMMENDED that your Board, as the Board of Directors for the Redevelopment Agency, approve the attached contract amendment with Haro Kasunich and Associates for an amount not to exceed \$8,500 for additional services for the Anna Jean Cummings Park.
