ADOPT CHANGES TO SALARY RESOLUTION NO. 279-75 AFFECTING THE CLASSIFICATION AND SALARIES OF VARIOUS DEPARTMENT OF CHILD SUPPORT SERVICES POSITIONS

Dear Members of the Board:

As you are aware, the Legislature has mandated all counties to transition the District Attorney Family Support Division to a newly created County Department of Child Support Services.

As one of the first transitional counties, the County of Santa Cruz must finalize the transition by January 1, 2001. As part of this process, the Personnel Department has conducted a review of the positions in the Family Support Division and recommends the following:

I. Title Changes Only

As the programs will no longer be called Family Support, all titles within the current Family Support Division must be retitled to be consistent with the new name of The Department of Child Support Services. The duties will remain the same. The following chart illustrates the proposed title changes.

Supervising Family Support Officer	Supervising Child Support Officer

II. <u>District Attorney I-IV Series</u>

The District Attorney I-IV job specification was revised to reflect the State-mandated changes. Additionally, consistent with State requirements, a new Child Support Attorney I-IV series is being proposed at the same salary ranges as the current District Attorney I-IV and County Counsel I-IV series. It is recommended that this position be placed in the District Attorney Association unit. The District Attorney Association is in agreement with this action. The District Attorney Association has indicated their intent to rename their association to include the Child Support Attorneys.

III. <u>District Attornev Inspector</u>

No changes were made to the District Attorney Inspector job specifications.

Consistent with State requirements, a new Child Support Investigator I/II series was created with a recommended salary equivalent to the Welfare Fraud Investigator I/II (Level I = KL \$16.53 - 20.90 and Level II U8 = \$21.22 - 23.87). It is recommended that this position be placed in the General unit with the Welfare Fraud Investigators. There is only one position allocated to this classification and it is currently vacant.

It is THEREFORE RECOMMENDED that your Board:

- 1. change the titles of the Family Support Interviewer I/II, Family Support Officer, Family Support Manager, Supervising Family Support Officers to Child Support Interviewer I/II, Child Support Officer, Child Support Manager and Supervising Child Support Officers;
- adopt the attached resolution amending Salary Resolution No. 279-75 establishing the new classification of Child Support Attorney I/II/III/IV; establishing the salary ranges as follows: I) UG \$20.65-27.68; II) UM \$25.57-34.26; III) UP \$28.38-38.03; and IV) US \$32.20-43.14; place this classification in the District Attorney Association unit; and
- adopt the attached resolution amending Salary Resolution No. 279-75 establishing a new classification of Child Support Investigator I/II at the salary ranges of I) KL \$16.53-20.90; and II) U8 \$21.22-23.87 and place this classification in the General unit as recommended.
