# SUBJECT: PROPOSED MULTI-WAY STOP FOR GROSS ROAD AT GROSS ROAD AND SOQUEL AVENUE/40TH AVENUE

Members of the Board:

The Department of Public Works has concluded a traffic analysis for the Gross Road and Soquel Avenue/40th Avenue Intersection, and we have determined that the safety of the community warrants the installation of multi-way stop signs at this location. A location map is attached for reference.

Public Works has reviewed the intersection and has determined that the existing combination of **geometrics** and current traffic control measures are limited in providing efficient traffic operations. The installation of stop signs on Gross Road would improve the operation of the intersection by allowing the through traffic on Soquel Avenue to make a more efficient turn onto Gross Road. This major traffic movement is currently constrained since it must relinquish the right-of-way to vehicles on Gross Road. Therefore, Public Works supports the installation of the multi-way stop in order to continue providing improved safety and efficient traffic operations at this intersection.

A professional office building development now under construction at the northeast corner of the intersection was conditioned to provide a westbound right-turn lane on Gross Road to Soquel Avenue. Because this right turn is one of the major movements at the intersection, the installation of multi-way stop signs could not be recommended without the construction of this right-turn lane, which was recently completed. Without the right-turn lane, the delay and queues associated with a multi-way stop would have negatively **impacted the** 41st Avenue/Gross Road intersection operations. This was confirmed in a multi-way stop sign traffic volume warrants analysis and an intersection level of service analysis performed by Higgins Associates (attached) for the office building development in May 1998. In addition, a yield sign must be installed on Gross

Road for the right-turn movements onto Soquel Avenue.

The City of Capitola in cooperation with the County Redevelopment Department is also finalizing plans to improve Gross Road from Soquel Avenue to 4 1 st Avenue with sidewalks and an additional eastbound right-turn lane on Gross Road to 4 1 st Avenue. The construction of these improvements is tentatively scheduled for spring 2001. The installation of the multi-way stop sign would benefit local traffic during the construction phase of the Gross Road Project.

It is therefore recommended that the Board of Supervisors adopt the attached ordinance in concept, and place the ordinance on the next available agenda for final adoption.


