On November 14, 2000, the Board of Supervisors received one bid for the subject project, and the bid was found to be in order. The engineer's estimate was \$135,000.00. The low bidder was Wolcott Construction of Santa Cruz in the amount of \$162,265.75. Sufficient funds are available in the 2000/2001 Public Works Budget to cover this expenditure plus contingencies and administration.

It is therefore recommended that the Board of Supervisors take the following action:

1. Accept the low bid of Wolcott Construction in the amount of \$162,265.75 and authorize the award of the contract.
2. Authorize the Director of Public Works to sign the contract on behalf of the County.
