Subject: DRAFT STRATEGIC PLAN FROM CHILDREN & FAMILIES COMMISSION

Dear Board Members:

As your Board is aware, Proposition 10 established a funding stream for a variety of services to young children and their families. Your Board, in accordance with State law, established the Children and Families Commission to implement the mandates of the proposition and establish funding priorities. Your Board has three county representatives on the Commission: Supervisor Almquist, Cecilia Espinola, HRA Administrator and Rama Khalsa, HSA Administrator.

The Commission has been engaged in a community assessment process to determine how local citizens feel children from birth to 5 years old and their families can best be served by the new funding. The law requires that the strategic plan evaluate health, family support, and children's readiness to learn on entering kindergarten. Funded services are to address these three areas. The extensive civic engagement process resulted in a rich profile of different needs for the County's children and their families. The civic engagement results will be shared with other agencies and programs serving youth and can be updated as the Proposition 10 funded programs are implemented to track results and impacts.

The primary purpose of the civic engagement progress was to identify these needs and priorities for the strategic plan for Santa Cruz County. The strategic plan is the basis for the funding priorities for the first year of Proposition 10 grants. There is approximately 3.7 million dollars available on an annual basis which may be spent as part of implementing the strategic plan. The draft Strategic Plan will be released November 1 5th and be made available to your Board immediately. The Commission is both seeking verbal and written comments on the draft plan from the community. There will be a series of

public hearings on the draft plan. Details on the hearings are attached. A final revised plan will come before the Commission on December 13, 2000. The timelines for these hearings and the first funding cycle for Proposition 10 funds are also included for your information.

Given the pivotal role of County government in delivery of services to children and youth, it is both appropriate and essential that the draft plan be presented to and considered by your Board.

Recommendations:

It is therefore RECOMMENDED that your Board:

Consider this report and schedule time on your Board's December 5th agenda for questions and comments on the draft Strategic Plan.
