RE: PURCHASE OF FIXED ASSET FOR SANTA CRUZ COUNTY AUTOMOBILE RECOVERY UNIT

Dear Members of the Board:

It is the request of the District Attorney that your Board authorize an expenditure not to exceed \$2,600 for the purchase of a lap top computer for use within the Santa Cruz County Automobile Recovery Unit.

As authorized within the California Vehicle Code Section 9250.14, funds are made available to the County for it exclusive use to fund programs that enhance the capacity of local police and prosecutors to deter, investigate and prosecute vehicle theft crimes. The procurement of the requested computer equipment is to be used solely for the purpose set forth within the statute by the District Attorney investigator assigned to the Automobile Recovery Unit.

The following equipment has been reviewed and approved for the application described herein by the Information Systems Department:

(1) IBM ThinkPad A20, 15" Display

THEREFORE, IT IS RECOMMENDED THAT YOUR BOARD approve the purchase of a lap top computer for the Santa Cruz County Automobile Recovery Unit and authorize the transfer of funds as described in the attached AUD-74.
