On November 14, 2000, J. C. Randolph, Inc. completed the Watsonville Court Waterline & Walkway Project. The original bid amount was \$17,076. One approved change order for necessary repairs to the waterline which were not shown on the original plans was issued which increased construction costs by \$1,708. The total construction cost for this project was \$18,784.

It is therefore RECOMMENDED that your Board take the following actions:

- 1) Accept the project as completed;
- 2) Approve the final cost of \$18,784;
- 3) Authorize the Clerk of the Board to file the executed Notice of Completion with the office of the County Recorder, a copy of which is attached.
