Dear Members of the Board:

During the 2000/01 Budget, your Board approved the Sheriffs continuing contract for security services with the Santa Cruz County Superior Court. The final accounting has now been completed for fiscal year 1999/2000. We have met with Christine Patton, Executive Officer for the Courts, and have agreed there is an unexpended amount of \$80,274 from the 99/00 contract year. According to our contract with the Courts, these funds need to be appropriated into the current fiscal year, 2000/01.


