REQUEST FOR APPROVAL OF CALIFORNIA DEPARTMENT OF EDUCATION AMENDMENTS TO AGREEMENTS FAPP-0068, F2AP-0064, F3TO-0070, & GAPP-0068

Dear Members of the Board:

As you know, the Human Resources Agency (HRA) contracts with the California Department of Education (CDE) to provide subsidized child care services to eligible families in Santa Cruz County, including CalWORKs Stages 2 and 3 child care services. In August your Board approved contracts for these services for the FY2000-01. The purpose of this letter is to request that your Board approve amendments to four contracts for child care services, and increase the funds available to provide these services.

Agreement FAPP-0068 for the Child Care and Development Block Grant Program provides subsidies to parents who are income eligible and who establish a qualifying need for child care services and for activities including employment, limited job search and employment training. The additional amount available for these services through Amendment 01 to the agreement is \$20,267 for a total contract amount of \$733,877. The Funding Terms and Conditions for this agreement have not been changed.

Agreement F2AP-0064 provides child care for CalWORKs participants whose welfare to work activities and child care needs have stabilized, and for those participants who are making a transition from cash grants to self-sufficiency. The additional amount available for these services through Amendment 01 to the agreement is \$101,002 for a total contract amount of \$859,477.

The Funding Terms and Conditions for this agreement have been amended to align this program with other Department of Education programs with respect to the percentage of subsidized children a provider may serve. The amendment also provides for exceptions necessary to meet family needs.

Agreement F3TO-0070 provides child care subsidies to income eligible families who have reached their 24 month post-public assistance time limit on Stage 2 child care. The additional amount available for these services through Amendment 01 to this agreement is \$304,015 for a total contract amount of \$428,545. The Funding Terms and Conditions for this agreement have also been amended as described above.

Finally, Agreement GAPP-0068 for the Alternative Payment Program also provides subsidies to parents who are income eligible or receiving public assistance, and who establish a qualifying need for child care services. In addition to basic eligibility and income priority requirements, the program also serves children who are receiving child protective services or are at risk of abuse or neglect as an immediate priority regardless of income. The additional amount available for these services through Amendment 01 to this agreement is \$22,703 for a total contract amount of \$738,889. The Funding Terms and Conditions for this agreement remain unchanged.

All of the amended contracts along with the funding terms and conditions, which describe the requirements for the agreement, are on file with the Clerk of the Board. Funds were allocated for these services in HRA's FY2000-01 budgets; however, as a result of the contract amendments, additional funds in the amount of \$447,987 must be accepted by HRA, as shown in the attached AUD60. This represents no additional County costs.

IT IS THEREFORE RECOMMENDED that your Board take the following actions:

1. Adopt the Resolution accepting unanticipated revenue in the amount of \$447,987 and appropriate these funds as described in the attached AUD60;
2. Adopt the Resolution certifying your Board's approval to accept Amended Agreement FAPP-0068 with the California Department of Education for \$733,877 (Attachment 1), and authorize the Human Resources Agency Administrator to execute Amended Agreement FAPP-0068 and to make subsequent minor changes thereto when appropriate and necessary;
3. Adopt the Resolution certifying your Board's approval to accept Amended Agreement F2AP-0064 with the California Department of Education for \$859,477 (Attachment 2), and authorize the Human Resources Agency Administrator to execute Amended Agreement F2AP-0064 and to make subsequent minor changes thereto when appropriate and necessary;

5. Adopt the Resolution certifying your Board's approval to accept Amended Agreement GAPP-0068 with the California Department of Education for \$738,889 (Attachment 4), and authorize the Human Resources Agency Administrator to execute Amended Agreement GAPP-0068 and to make subsequent minor changes thereto when appropriate and necessary.

Section IX. Program Requirement, Procedures for Provider Participation (p.36) shall be amended as follows:

The contractor shall develop and implement written policies and procedures for provider participation which include the following:

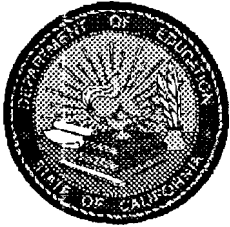
A. Maximizing parental choice with consideration of the contractor's ability to pay for the services within the funding provided in the annual child development contract

B.6: Procedures for ensuring that the provider selected by the parent is licensed or a registered child care provider prior to receiving payments for services, that exempt family child care or in-home providers (except grandparents, aunts and uncles) complete a health and safety self-certification and Trustline application process within fourteen (14) calendar days, and acceptance, rejection and termination of provider affiliation with the program including termination of payment to a denied Trustline applicant after providing the parent with a Notice of Action allowing fourteen (14) calendar days to select another provider and 2) *alternative payment* programs may provide *payment to child care facilities with at least 75 percent subsidized children in any of the following circumstances:*

- 1 *There is a lack of licensed child care facilities in the area.*
- 2 *The facility is not able to meet the special needs of a particular child.*
- 3 *Any other reason provided for by the department's regulations.*

C. Grievance procedures for parents and providers in the program.

D. Requirement that the parent(s) have unlimited access to their children and those caring for their children during normal hours of provider operation and whenever the children are in the care of the provider

Section IX. Program Requirement, Procedures for Provider Participation (p.36) shall be amended as follows:

The contractor shall develop and implement written policies and procedures for provider participation which include the following:

- A. Maximizing parental choice with consideration of the contractor's ability to pay for the services within the funding provided in the annual child development contract
- B. Procedures for 1) ensuring that the provider selected by the parent is licensed or a registered child care provider prior to receiving payments for services and that exempt family child care or in-home providers (except grandparents, aunts and uncles) complete a health and safety self-certification and Trustline application process within fourteen (14) calendar days, 2) acceptance, rejection and termination of provider affiliation with the program including termination of payment to a denied Trustline applicant after providing the parent with a Notice of Action allowing fourteen (14) calendar days to select another provider; and 3) *alternative payment programs providing payment to child care facilities with at least 75 percent subsidized children in any of the following Circumstances:*
 - a. *There is a lack of licensed child care facilities in the area.*
 - b. *The facility is not able to meet the special needs of a particular child.*
 - c. *Any other reason provided for by the department's regulations.*
- C. Grievance procedures for parents and providers in the program.
- D. Requirement that the parent(s) have unlimited access to their children and those caring for their children during normal hours of provider operation and whenever the children are in the care of the provider
