

SUBJECT: RESOLUTION OF INTENTION TO ANNEX TERRITORY DESIGNATED

AS ANNEXATION NO. 124 TO ZONE "A" OF COUNTY SERVICE AREA

NO. 9

Members of the Board:

The Department of Public Works has received a petition requesting annexation to Zone "A" of County Service Area No. 9 (CSA 9A) for the purpose of including parcels in the residential street lighting district (Exhibit "B"). The signatures on the petition have been checked by this office and amount to 61 percent of the property owners in the area of benefit. The parcels comprise a portion of the Mesa Village Subdivision, which adjoins the existing CSA 9A lighting district boundary.

In order to annex the territory comprising the area of benefit, it will be necessary for your Board to accept the petition requesting the annexation, adopt the attached Resolution of Intention to Annex Territory to Zone A of County Service Area No. 9, set a date for a public hearing on the annexation which is not less than thirty nor more than sixty days after the adoption of the Resolution of Intention, give required notice of the meeting, and at the conclusion of the public hearing consider adoption of the attached resolution.

As a part of its required improvements the Mesa Village Subdivision installed six new 70-watt high power sodium vapor light fixtures, three of which are within the existing CSA 9A boundary along Mesa Verde Drive. There are sufficient funds to cover the cost of providing power to the new lights.

It is therefore recommended that the Board of Supervisors take the following action:

- 1. Accept the petition requesting annexation to Zone A of County Service Area No. 9.
- 2. Adopt the Resolution of Intention.
- 3. Set a public hearing for February 27, 2001, at 9:00 a.m. or thereafter.
- 4. Direct the Clerk of the Board to publish a notice of public hearing in a newspaper of general circulation at least seven days prior to the date of the public hearing.
- 5. Upon conclusion of the public hearing, consider adoption of the Resolution Annexing Territory to Zone A.
- 6. Approve the immediate addition of the three light fixtures installed within the existing CSA 9A boundary to the CSA 9A inventory, and direct the Clerk of the Board of Supervisors to notify the Pacific Gas and Electric Company.

RESOLUTION OF INTENTION TO ANNEX TERRITORY, DESIGNATED AS ANNEXATION NO. 124, TO ZONE "A" (RESIDENTIAL STREET LIGHTING)
OF COUNTY SERVICE AREA NO. 9

WHEREAS, this Board intends to annex certain territory in the Mesa Village subdivision to Zone "A" of County Service Area No. 9; and

WHEREAS, proceedings for the annexation of hereinafter described territory have been initiated by petition of the Santa Cruz County Board of Supervisors; and

WHEREAS, annexations to zones of County Service Areas are not subject to review by the Local Agency Formation Commission;

NOW, THEREFORE, BE IT RESOLVED AND ORDERED that this Board declare, and it hereby does declare, its intention to annex to Zone "A" of County Service Area No. 9, the territory described and shown on Exhibit "C" attached hereto.

BE IT FURTHER RESOLVED AND ORDERED that the 27th day of February, 2001, at the hour of 9:00 a.m. or thereafter in the Board of Supervisors Chambers, Governmental Center, Santa Cruz, California, be and is hereby fixed as the time and place for the hearing on said annexation.

BE IT FURTHER RESOLVED AND ORDERED that the Clerk be and hereby is directed to post a copy of this resolution as notice of time and place of said hearing on said annexation in accordance with Section 25210.16 of the Government Code, and publish notice of the public hearing once at least 7 days prior to the hearing.

BE IT FURTHER RESOLVED AND ORDERED that at the time, date, and place hereby set for public hearing, all interested parties may appear and be heard on the proposed annexation. Persons desiring to make a written protest against said annexation shall do so by written communication filed with the Clerk of this Board not later than the hour set for hearing. A written protest by a landowner shall contain a description sufficient to identify land owned by the landowner, and a protest by a voter shall contain the residential address of such voter. The foregoing information shall be included in the notice of public hearing by the Clerk.

- 3. The installation of street lights as shown on Exhibit "C" is hereby authorized.

- 1. The Department of Public Works request the Auditor-Controller to submit a warrant to the Clerk of the Board, made out to the State Board of Equalization, in the amount of \$250.
- 2. The Clerk of the Board shall file a certified copy of this resolution, a copy of the legal description and map, and said warrant with the State Board of Equalization in Sacramento.



SITUATE IN THE COUNTY OF SANTA CRUZ, STATE OF CALIFORNIA AND 0426 BEING A PORTION OF THE RANCHO DE LOS CORRALITOS IN PROJECTED SECTIONS 16 AND 17, TOWNSHIP 11 SOUTH, RANGE 2 EAST, MOUNT DIABLO BASE AND MERIDIAN AND DESCRIBED AS FOLLOWS:
