## QUEEN MARY FOOD SERVICE MOBILE RACK

Dear Members of the Board:

During the 2000/2001 Budget Hearings, your Board approved the Sheriffs Budget, which included the purchase of a replacement Queen Mary food service mobile rack that transports the food for inmates from the Rountree kitchen to the Minimum Security facility. The anticipated cost was \$2,800. We have since worked with General Services and found that the cost of this equipment has increased to a total of \$4,000.

Our current Queen Mary rack has numerous damage and welds that are failing.

It is necessary to augment the amount already approved by your Board by \$1,200. We have current savings in our fixed assets from items that were purchased for less than anticipated in our Rountree Facility budget (662500).

It is, therefore, recommended that your Board:

1. APPROVE the attached transfer of funds within the Detention Bureau in the amount of \$1,200; and

2. AUTHORIZE the total amount of \$4,000 for the purchase of a Queen Mary food service mobile rack.
