RE: APPROVE ACCEPTANCE OF CAR SEAT GRANT AWARD

Dear Board Members:

On October 25, 2000, the Health Services Agency reported to your Board that the Maternal, Child and Adolescent Health Unit (MCAH) was currently seeking funds for additional child car safety seats that would continue to meet the community need for free or low-cost car seats that meet federal safety standards. We are pleased to announce that a grant award of \$14,644 from the Pajaro Valley Community Health Trust to purchase child car safety seats is available pending acceptance by your Board. The grant proposal and a resolution accepting and appropriating this unanticipated revenue are attached.

In January, 2000, that the Maternal, Child and Adolescent Health Unit began a collaborative project to provide car seats and car seat safety information and education to low-income teenage mothers and families. The car seat project was originally implemented in partnership with the Watsonville Community Hospital Maternity Unit, the Watsonville Family Resource Center, and the Santa Cruz County Head Start. The project has been very successful with an ever-increasing demand for more car seats. Both Salud Para La Gente Health Clinic and the Pajaro Valley Unified School District Healthy Start have now joined the collaborative. The project, known as Seats for Kids/Sillas Para Los Niños, will be able purchase 351 additional child car safety seats with the new grant from the Pajaro Valley Community Health Trust. These car seats will be distributed to families of children living in the Pajaro Valley. There are no additional County costs.

#### It is therefore RECOMMENDED that your Board:

- 1. Authorize acceptance of the \$14,644 grant from the Pajaro Valley Community Health Trust for the purchase of child car safety seats; and
- 2. Adopt resolution accepting and appropriating \$14,644 in unanticipated revenue for the Maternal, Child and Adolescent Health program.

#### A. Description of Project

In January, 2000, the Maternal, Child and Adolescent Health Unit of the Santa Cruz County Health Services Agency (MCAH) began a collaborative project to provide car seats and car seat safety information and education to low-income teenage mothers and families. The project was initiated based on the community need for free or low cost child passenger restraints that meet federal safety standards. Although car seats have been accessible to some families through a countywide loaner program, availability of seats through this program is very limited and hundreds of families may be transporting their infants and young children without adequate safety seat protection. The south county area in particular, is a community of great need, having the highest proportion of low-income and Latino families, as well as teenage mothers, compared to other areas of Santa Cruz county. The car seat program was therefore implemented in partnership with the Watsonville Community Hospital Maternity Unit and the Watsonville Family Resource Center (WFRC), a multi-agency services and resource center for low-income families and children, and Santa Cruz County Head Start.

Parents are eligible to receive a car seat based on economic need and participation in one of the health, social and/or educational programs of the partner agencies. Parents receive information about child passenger safety, hands-on installation instruction of a new car seat appropriate for their child. Parents are required to demonstrate proficiency in installing the car seat and must sign a consent form prior to receiving the seat,

Seed money for the project was provided through the California State Automobile Association's "Take a Seat" program for the purchase of 200 car seats. Collaborative agencies staff received a basic, one-day training on car seat safety and installation, but participants were strongly advised by the grantee and trainer to complete National Highway Traffic Safety Association (NHTSA) technician certification training. Subsequently, the collaborative was awarded a training grant through the California Kids' Plates/Center for Childhood Injury Prevention to send five staff to the NHTSA training during the grant period September 2000 to March 2001.

Since the inception of the project, most of the car seats purchased have already been disseminated to families with identified need. The supply of car seats is expected to be exhausted by the end of the year 2000. The project's demand has increased even more, since Salud Para La Gente Health Clinic and PVUSD Healthy Start, current car seat loaner program participants, have joined the collaborative, which we have named SEATS FOR KIDS/SILLAS PARA LOS NINOS. In addition, as of January 2002, SB 567 will go into effect in California, requiring children up to six years old or 60 pounds to be secured in an approved child restraint device, thereby increasing the need for booster seat use among children who have outgrown standardized car seats.

An extensive study by the National SAFE KIDS Campaign showed a car seat misuse rate of 85%. Accurate, up-to-date information and provision of low/no-cost car seats is vital to protecting our communities' children. The objectives of the SEATS FOR KIDS collaborative are to, 1) increase regular and proper use of car seats among county

other restraint systems at all times; and 3) increase collaborative efforts among community providers towards the goal of protecting the safety our children.

Evaluation methods for the SEATS FOR KIDS project will include, 1) partner agencies will report number of car seats given out and client demographics to project coordinator to identify utilization rates and future equipment needs; and 2) project coordinator will collect information, as available, on misuse rates at car seat safety checkup events to be held in coordination with the local California Highway Patrol Community Education Officer.

Additional funding sources will continue to be sought to maintain and expand the current child passenger safety seat program. In addition to the training grant submitted to the Center for Childhood Injury Prevention earlier this year, a proposal for equipment was also submitted. Although the equipment request was declined due to the large number of grants submitted statewide, they stated in their response letter that they may pass our proposal onto to other funding agencies for. The project coordinator has also contacted the California State Automobile Association to discuss additional funding possibilities and Health Services Agency's grant proposal to the Proposition 10 Commission will include a request for child passenger restraint funding, as well. Target Stores may be also be considered, as they have donated car seats to Salud Para La Gente in the past.

#### B. Organizational Background

The Santa Cruz County Health Services Agency (HSA) is charged to protect and improve the health of its people. In pursuit of this mission, HSA provides programs in Environmental Health, Public Health, Medical Care, Substance Abuse Prevention and Treatment, and Mental Health. The Maternal Child and Adolescent Health (MCAH) program lies within the Public Health division of the agency which also includes Public Health Field Nursing, Communicable Disease Management, HIV Testing, Early Intervention Care Services, Community Health Promotion and Prevention, Children's Services, Women's Services, and the Homeless Person's Health Project. The County Health Officer and the Chief of Public Health direct the division. The County Board of Supervisors are the final approving authorities.

During the fiscal year 1999-2000, the Pregnancy, Outreach and Education unit of MCAH served over 500 pregnant and parenting women in the south county area; 50% were teens and 70% were Hispanic. The public health nursing home visiting programs had a caseload of over 1,000 clients. Over 80% of the Adolescent Family Life Program caseload of 92 pregnant and parenting teens and 20 of their siblings live in the 95076 zip code area. In addition, MCAH staff provided training and served as referral and resource staff for community health care and other service providers throughout the county.

Health Services Agency has extensive experience and expertise serving as the fiscal administrator for collaborative projects. The SEATS FOR KIDS project coordinator, Katie LeBaron, MPH, has completed the NHTSA child passenger safety technician certification training and currently oversees the program and facilitates coordination of staff trainings and other project-related activities.

Among the numerous goals and objectives stated in the State and local MCH five-year plan is the objective of reducing deaths of children caused by unintentional. Since the leading cause of death due to unintentional injury is motor vehicle crashes, SEATS FOR KIDS collaborative project is an important step towards meeting that objective and working for the overall goal of a safe and healthy environment for children and families.

#### C. Community Support and Involvement

All Public Health staff in Santa Cruz county maintain a high level of involvement in the community, both on an individual service provision level (home visiting) and on a macro level by involvement in the numerous collaboratives, networks and commissions. MCAH staff work collaboratively with numerous community organizations and groups, including, Women, Infant and Children Program, Watsonville Community Hospital, Healthy Families Assistor sites, Teenage Mothers and other local high school programs, Children's Commission, Pajaro Valley Healthy Start Collaborative, Happy Tooth and DIENTES Clinic, Las Hermanas, Nursing Mothers Council, Migrant Head Start, Answers Benefiting Children/La Manzana Family Resource Center, Adelante, All Kids by Two Immunization Coalition, Central Coast Alliance for Health, Childhood Lead Poisoning Prevention Project, Migrant Head Start Health Advisory Committee and many more. The Public Health Nursing Unit participates in a tri-county project with Santa Clara and Monterey, implementing the David Old's home visiting program for first time moms. MCAH and other Public Health representatives continue to play a key role as public informants regarding critical issues affecting the health and safety of children and families in our communities.

#### D. SEATS FOR KIDS Budget Summary

SEATS FOR KIDS collaborative project is requesting the amount of \$14,643.80 for the purchase of 351 car seats. Evenflo Company, Inc.has been identified by project staff to have the most competitive prices for the quality of the equipment. Infant car seats with an adjustable base are preferable to those without, because the base attachment helps reduce the risk of misuse caused by repeated installation. For most families, the preferred booster seat will be the new Evenflo *Express* model, which converts from a forward facing, five-point harness system to a high back booster. Seats will be distributed to collaborative partner agencies, according to expected need and client caseload, approximately as follows:

#### Dear Katie,

The Watsonville Family Resource Center Family Health & Education Center, is a collaborative in which many co-located services are located to best serve the needs of the Watsonville community at 18 West Lake Ave. All of the services provided at WFRC arc for English or monolingual Spanish speaking families. The majority of the clients chat receive services through the WFRC are low-income, Latino and many are teenage parents. The Answers Benefiting Children home visiting program provides services to 125 families. The ABC is a collaborative with Health Services Agency, Human Resources Agency, Families in Transition, Parents Center and Early Head Start. The services at the WFRC include: parenting classes open to the community, therapeutic counseling and groups.

The WFRC also works closely with agencies such as W.I.C.; a nutrition education program for mothers and young children aged O-5 and Adclante, a program that helps parents with translation services. These programs are co-located in the La Manzana Cenrer.

In January 2000. "Take a Car Seat Program" started at the WFRC. Health Services Agency provided some training for ABC staff. Lynda Lewit, PHN has served as liaison between HSA and the WFRC "'fake a Car Seat Program". Since then, 41 car seats (average of 4 seats a month) have been given and training provided on proper installation. The family performs a return demonstration during this training. AU families in the home visiting program are screened for car seat safety. Ana Alvarez, Administrative Assistant has enthusiastally assisted with the installation and teaching.

The WFRC wauld like to continue the collaborative effort To continue the "Take a Car Seat Program". The program has need for additional car scats. We estimate that additional 60 sears for the 2001 year would enable us to give away an average of 5 seats a month. We would like to train new staff on installation using the "Kids Place Program" A future goal would be to designate a staff member to complete the Technician Certification training by the National Highway Safety Traffic Association Program. This staff would serve as an "expert" resource and we could one-day do community car scat screening and education.

We are grateful that the Pajaro Valley Community Health Trust is considering supporting this important program.

I am writing this letter to express Salud **Para** La Gente's interest in partnering with Santa Cruz County Health Services Agency to provide child passenger safety seats and education for south county residents through the '**Seat For Kids**" collaborative project. Salud provides prenatal and pediatric services to approximately 2,300 families, most of whom are Hispanic, low-income and live in the **Watsonville/Pajaro** area. There is a great need for child restraints that meet federal safety standards among our clients and the community -many of our families cannot afford to buy a new car seat and resort to getting a used one from family, friends or a second-hand store, or do not to use a car seat at all. Although Salud is a car seat loaner program **site**, the demand is much **greater than the supply of seats through this program**.

Salud will work with the "Seat For Kids" collaborative project coordinator to ensure that staff are properly trained in child passenger safety education and installation of the car seats to be provided to us. Salud staff will ensure that all parents who receive a seat will be instructed in its use, advised of current and upcoming child passenger restraint laws and sign the 'Seat For Kids" consent form (see attached). Salud also agrees to keep records of and report to the "Seat For Kids" project coordinator the number of seats given out and demographic data included on the consent form.

**Salud Para** La Gente looks **forward** to participating in this collaborative project. Funding support from **the Pajaro Valley Community** Health Trust will **serve** as an important step towards helping our community establish a comprehensive child passenger safety program.

Dear Katie:

Head Start is most interested in partnering with HSA and other agencies to ensure that needy families have access to car safety seats. Last year, as you know, Head Start hosted an event in Watsonville to install new car seats for about 30 families enrolled in our program. It was a very successful event and much appreciated by participating families.

During this event, several parents traded their current car seat for a new one---most of these would have provided little protection for the user in case of an accident due to such factors as deterioration of safety features (age and condition), wrong size for the child, and improper installation.

There are many more families here in Watsonville who need safety seats which will provide the protection they expect. At least 90% of Head Start's 438 families are low-income...a family of 4 makes less than \$17,000 annually. Many families, therefore, cannot afford to purchase a new car seat. If they have one at all, it is usually purchased at a garage sale or handed down **from** someone else. Of course, no instructions accompany these seats and most don't understand the importance of installation in regard to protecting the child should an accident occur.

We are ready to participate. We have secured storage for the seats and our Family Service Workers will **identify** needy families **from** our Watsonville centers. We expect to handle distribution and installation much as last year, which went smoothly.

We look forward to working with you on this project and to making young children safer.
