ADOPT RESOLUTION TO IMPLEMENT CLASSIFICATION AND SALARY ACTION IN THE INFORMATION SERVICES DEPARTMENT

Dear Members of the Board:

This letter, with its accompanying resolution recommends establishing a new classification and salary series for the new position responsible for supporting the County's wide and local area networks.

During Budget Hearings, your Board approved the recommended Information Services Department budget, which included a new position to support the County's wide and local area networks. The approved position was forwarded to Personnel for classification. Personnel has since completed a classification and salary study and recommends the establishment of a new classification titled Network Support Analyst. It is further recommended that the salary range for the new Network Support Analyst be \$4094 - \$5177.


This new position creates a new classification series which serves as a promotional track for the Computer Operations Technician series. As a result, two additional classifications have been created; an Assistant Network Support Analyst and a Network Support Specialist. It is recommended that the salary range for the new Assistant Network Support Analyst be \$3480 - \$4403, and that the salary range for the new Network Support Specialist be \$2908 - \$3682.

The Information Services Department and the employee representation are in agreement with this recommendation and funding for this action is included in the department's budget.

It is therefore RECOMMENDED that your Board:


1. Adopt the attached amendment to Resolution No. 279-75 to create a new classification of Network Support Analyst at the salary range of No. XT (\$23.62 - \$29.87 per hour), Assistant Network Support Analyst at the salary range of No. XM (\$20.08 - \$25.40 per hour), and Network Support Specialist at the salary range of No. WU (\$16.78 - \$21.24 per hour) effective 12:01 a.m. on February 17, 2001; and
2. Designate the classifications of Network Support Analyst, Assistant Network Support Analyst, and Network Support Specialist to the General Representation Unit.

3. Adding a new class of Network Support Specialist, Class No. UO1, at salary range No. WU \$16.78 - \$21.24 per hour.


