SUBJECT: MODIFICATIONS OF LITTER AND SIGN TRUCKS

Members of the Board:

The Public Works Department is proposing modifications of recently purchased litter and sign trucks for the Road Maintenance section. Although the modifications to the two trucks are considered minor, they will provide for improved operation and safety for the Road Maintenance section during the life of the trucks. The modifications include additional safety lighting for night time use of the trucks, additional storage facilities for tools, and other miscellaneous improvements. The cost of the modifications of both trucks is \$3,150.00, and funding is available from savings of \$3,150.00 from the purchase of two 3/4 ton pickup trucks.

It is therefore recommended that the Board of Supervisors approve the transfer of funds (AUD 74) authorizing the use of \$3,150.00 savings on the purchase of two pickup trucks to provide for modifications to litter and sign trucks for the Public Works Road Maintenance section.
