> **Amendment of County Code Relating to Reporting of Vacancies** Re:

Dear Members of the Board:

On February 6, 2001, your Board directed this Office to return with an ordinance amending Subdivision B. of Section 2.38.200 of the Santa Cruz County Code relating to the reporting of vacancies. This direction resulted from a request received from the County's Commission on Disabilities, which had sought this change. The proposed amendment would correct terminology used to describe a circumstance whereby an vacancy on a County commission or committee is created due to the physical or mental "incapacitation" of a member. Vacancies created by a member's incapacity must be reported to your Board and the Clerk of the Board.

IT IS THEREFORE RECOMMENDED that your Board consider approving in concept the attached ordinance amending Subdivision B. of Section 2.38.200 of the Santa Cruz County Code relating to the reporting of vacancies, and place said ordinance on your next available agenda for final adoption
