While raised in a very Catholic family, both my parents had a strong respect for the role of science and people's need for and access to health services. Over the years, both as a public employee (18 years with the City of Santa Cruz Public Works Department) and a community member, I have become increasingly convinced that addressing disease and prevention is best done through the public health perspective. When we try to develop solutions based on individual philosophic or moral positions, we invariably add to the problem.

I would appreciate an opportunity to work with and learn from your staff and current commissioners. While serving on the Santa Cruz City School Board, I had the pleasure to work with Betsy 'McCarty, who I understand is one of the commission's resource staff. I have never been involved in a policy decision where I disagreed with Betsy's position. It would be an honor to work with her.

I am also a diabetic. As a person with a chronic disease, I constantly confront the great divide in the care we offer as a society for the insured and the uninsured. For people with chronic diseases, this directly impacts their mortality. I have great respect for the work this county has done to extend health care to the uninsured; and I would hope to have an opportunity to build on that foundation.
