**RE: RESOLUTION ACCEPTING UNANTICIPATED REVENUE FROM
HAZARDOUS WASTE ENFORCEMENT TRUST FUND AND MAKING
APPROPRIATION FOR FIXED ASSET PURCHASE BY
ENVIRONMENTAL HEALTH SERVICES**

Dear Board Members:


Environmental Health Services on occasion receives a portion of the fine and penalties collected by the District Attorney or the State Department of Toxic Substances Control from local firms found in violation of the laws relative to hazardous waste control. These revenues are maintained by Environmental Health in a Hazardous Waste Enforcement Trust Fund, which, pursuant to the law, can only be used to fund the activities of the local Health Officer in enforcement of the Hazardous Waste Control Law.

Environmental Health is proposing to spend \$3,500 from the Trust Fund to purchase one combustible gas detector, replacing one of two gas detectors that have reached their useful life span. (A second detector will be replaced in the next budget cycle.) Funds would be taken from the Trust Fund and transferred to the appropriate fixed asset account in the Environmental Health budget to accomplish the purchase.

It is therefore **RECOMMENDED** that your Board:

1. Adopt the attached resolution accepting and appropriating unanticipated revenue in the amount of \$3,500; and
2. Authorize the purchase of one combustible gas detector as a fixed asset by Environmental Health Services.


