SUBJECT: GROSS ROAD/SOUTH RODEO GULCH ROAD, ROAD BUMPS

Members of the Board:

The residents of the Gross Road and South Rodeo Gulch Road areas have submitted an application along with a petition of affirmation signed by 58.4 percent of the total points calculated by the Department of Public Works for the installation of seven road bumps as shown on the attached map of the Gross Road/South Rodeo Gulch Road road bump affected areas. A letter from the Soquel Elementary School District in support of the road bumps has been received by the Public Works Department. The Central Fire Protection District policy on road bumps states "It is not this Department's policy or standard to promote the installation of speed bumps that would encroach upon any alley, lane or street utilized by the Central Fire Protection District."

The residents of the affected areas have complied with all the provisions of the Policy, and the streets meet all the eligibility requirements for placement of road bumps. The Policy requires approval by the Board of Supervisors prior to the placement of the bumps.

The developers of Rodeo Creek Subdivision, Tract 143 1, (Permit No. 99-0130), and the adjacent minor land division (Permit No. 98-0610) at the end of Gross Road have been conditioned to pay for the residents' share of road bump costs on Gross Road. There are six road bumps proposed for Gross Road at a cost of \$1,000 per bump (residents' cost). The developers will be required to pay $$6,000 ($1,000 \times 6 = $6,000)$.

In addition, the residents requested a road bump on South Rodeo Gulch Road between Soquel Avenue and Gross Road. The Department of Public Works recommends that the developer pay for this road bump and that your Board approve a Transportation Improvement Area fee credit of \$1,000 for the developers for the additional road bump. The Department of Public works will pay the balance of the costs to install the road bumps and provide the signs, pavement markings, and striping.

It is therefore recommended that the Board of Supervisors take the following action:

- 1. Adopt resolution authorizing the placement of seven road bumps on Gross Road and South Rodeo Gulch Road.
- 2. Approve funding of the road bump on South Rodeo Gulch Road as a fee credit to the developers of Permit No. 98-0610 and Permit No. 99-0130.



RESOLUTION NO.

On the motion of Supervisor duly seconded by Supervisor the following resolution is adopted:

RESOLUTION APPROVING THE INSTALLATION OF SEVEN ROAD BUMPS ON GROSS ROAD AND SOUTH RODEO GULCH ROAD

WHEREAS, on March 14, 2000, the Santa Cruz County Board of Supervisors approved a revised Policy and Design Criteria for the placement of road bumps on County maintained roads and within County service areas; and

WHEREAS, the residents of Gross Road and South Rodeo Gulch Road have submitted an application along with a petition of affirmation signed by 58.4 percent of the total points calculated by the Public Works Department requesting the installation of seven road bumps; and

WHEREAS, the Soquel Union Elementary School District has submitted a letter in support of the road bumps; and

WHEREAS, the residents of Gross Road and South Rodeo Gulch Road have complied with all the provisions of the Road Bump Policy; and

WHEREAS, the developer of Assessor's Parcel Numbers 03 1-03 1-1 5 and 32 pursuant to Permit Number 98-0610, to construct four single family homes, Condition III I, and/or pursuant to Permit Number 99-O 130, Condition III J, Tract 143 1, a 1 O-unit subdivision shall pay one-half the cost of the road bumps on Gross Road. That fee is established as \$1,000 per bump for a total of 6 bumps x \$1,000 = \$6,000. In addition the developer shall also pay the \$1,000 fee for the road bump on South Rodeo Gulch Road and receive a fee credit for that amount as part of the development; and

WHEREAS, Gross Road and South Rodeo Gulch Road meet all the eligible requirements for placement of road bumps; and

WHEREAS, the Road Bump Policy requires approval by the Board of Supervisors prior to placement of the bumps.

NOW, THEREFORE, BE IT RESOLVED AND ORDERED that seven road bumps be installed within the Gross Road and South Rodeo Gulch Road road bump affected areas in conformance with the Road Bump Policy and the Road Bump Design Criteria.



BE IT FURTHER RESOLVED AND ORDERED that the Public Works Department contract for the installation of the road bumps, and install the signs and pavement markings with County forces after payment of \$7,000 by the developer of Assessor's parcel numbers 03 1-03 1-1 5 and 32.
