damages sustained by Claimants, as stated above.

2 The name or names of the public employees responsible for 3 these wrongful acts are not completely known to Claimant, but are believed to include those operating in the County of Santa Cruz 4 5 in transportation and or traffic control departments. These 6 individuals were acting as employees or agents of the COUNTY OF 7 SANTA CRUZ, and were acting in accordance with programs and 8 policies of the COUNTY OF SANTA CRUZ which led to the dangerous 9 condition of the roadway which was a cause of the collision.

10 The complete nature and extent of the damages of Claimant 11 are not known at this time. However, Claimant alleges that the 12 damages and injuries he has sustained are for a value in excess 13 of the minimum recoveries for unlimited jurisdiction of the 14 Superior Court of the State of California.
