Adopt Resolution Accepting Unanticipated Revenue

Dear Members of the Board:

Each year the Agricultural Commissioner's Office receives state funding for enforcement activities. For fiscal year 2000-2001, the state made a one-time augmentation of \$6,500 to our contract specifically designated for the purchase of new computers to replace those currently in use.

We were not informed of the augmentation until **after** budget hearings, so the \$6,500 does not appear in our current budget. In order for us to properly receive and appropriate this revenue it is necessary for your Board to adopt a resolution accepting the unanticipated revenue. A resolution showing our proposed use of these funds is attached for your consideration and approval.

It is therefore RECOMMENDED that your Board adopt the attached resolution accepting and appropriating \$6,500 into Agricultural Commissioner Budget Unit 103210 for the purchase of computers.
