Dear Members of the Board:

Your Board previously established a policy authorizing the Redevelopment Agency Administrator to negotiate and execute all Agency rental agreements having a month-tomonth term and rent not exceeding \$5,000 per month. That policy also requires that the Redevelopment Agency Administrator submit annually to the Board, a continuing rental agreement list setting forth tenant names, assessor's parcel number, address, term, and brief descriptive remarks. That information is provided for the Agency properties in the Year 2001 Annual Continuing Rental Agreement List, attached to this letter.

In compliance with further requirements of the policy, the Agency Administrator has determined that each rental agreement referenced in the attachment serves the goals of the Redevelopment Plan for the Live **Oak/Soquel** Project Area. All agreements listed in the attachment have rents which do not exceed \$5,000 per month.

It is therefore RECOMMENDED that your Board, acting as the Redevelopment Agency Board of Directors, approve the attached Year 2001 Annual Continuing Rental Agreement List.
