SUBJECT: BEAN CREEK ROAD DRAINAGE AND EROSION CONTROL IMPROVEMENT PROJECT - MILE MARKER .83 - APN 070-131-15 & 17

Members of the Board:

Included in the 2000/01 budget are funds for construction of a storm drainage system from Bean Creek Road to Bean Creek. In conjunction with the County installing the improvements, the Santa Cruz County Resource Conservation District will stabilize the creek bank. The attached contract and right of entry provide for the acquisition of the necessary rights to construct and maintain the improvements (see attached map). The settlement amount for the property interests being acquired are shown in the attached Resolution and are based on a departmental appraisal. This amount is considered fair and reasonable for the real property interests being acquired and represents the fair market value for such property interests.

It is therefore recommended that the Board of Supervisors take the following action:

- Adopt the attached Resolution approving and accepting the terms and conditions of the contract and right of entry and authorize the Director of Public Works to sign said documents on behalf of the County;
- Approve payment of claims for the contract and right of entry.



CONTRACT

COUNTY OF SANTA CRUZ

- 1. The parties herein set forth the whole of their agreement. The performance of this agreement constitutes the entire consideration for this transaction.
- 2. SELLER agrees to execute and deliver a document in the form of an Easement Deed covering the property located at 1900 Bean Creek Road, Scotts Valley(APN 070-131-15), more particularly described in Exhibit "A", attached hereto and made a part hereof, and a (W-9) Request for Taxpayer Identification Number and Certification. Said documents shall be delivered to Scott Loichinger, Chief, Real Property Division of the COUNTY OF SANTA CRUZ, State of California.

3. The COUNTY shall:

- (A) Pay the undersigned SELLER the sum of \$350.00 for the property interest therein (including all improvements existing thereon unless removal is specifically authorized hereinafter in this Contract) as conveyed by Easement Deed after date title to said property interest vests in the COUNTY, free and clear of all liens, encumbrances, assessments, and taxes, except:
 - Covenants, conditions, restrictions and reservations of record, if any,
 Easements or rights of way over said land for
 - 2. Easements or rights of way over said land for utility or street purposes, if any.
- (B) Pay all escrow and recording fees incurred in this transaction. This transaction will be handled through an internal escrow by the County of Santa Cruz, Department of Public Works, Real Property Division, 701 Ocean Street, Rm 410, Santa Cruz CA 95060.
- 4. The provisions of this agreement shall inure to the benefit of and bind the respective successors, heirs, and assigns of the parties hereto.

- 5. Sellers hereby agree to allow the County of Santa Cruz access to the property covered under this contract anytime after September 11, 2000.
- 6. Said amount shown in clause 3(A) herin, includes the right of ingress and egress for the monitoring of Bean Creek during construction and the planting of vegetation for erosion control immediately adjacent to the easement area over APN 070-131-15, as shown on Exhibit "B" attached hereto and made a part hereof. Said right shall expire at the completion of the Bean Creek Road repair project or October 15, 2001, whichever occurs first.


Situate in the County of Santa Cruz, State of California, and described as follows:


Being a portion of the land conveyed to Kenneth J. Weinmann by that deed recorded September 3, 1996, Volume 5901 of Official Records of Santa Cruz County at Page 866, and more particularly described as follows:

Being a 20' wide easement for drainage construction and maintenance purposes over a portion of said lands of Weinmann, the centerline of which is described as follows:

Beginning at a point being the southwest comer of the land conveyed to Margaret M. Durney, by that deed recorded July 6, 1910 in Volume 290 of Official Records of Santa Cruz County at Page 144, and the northwest comer of the land described as Parcel B filed April 9, 1976 in Volume 20 Page 71 of Parcel Maps, Santa Cruz County Records; thence from said point of beginning along the southerly boundary of said lands of Dumey South 62°34' East 660.20 feet; thence North 13 "08' East 113.25 feet; thence South 84°25' East 46.90 feet; thence South 36°55' East 66.80 feet; thence South 16 "40' East 59.90 feet; thence South 37° 10' East 66.41 feet; thence North 77° 17' East 41.95 feet; thence North 33°02' East 113.19 feet; thence North 65°02' East 73.24 feet; thence North 6" 17' East 93.22 feet; thence North 60°47' East 105.87 feet; thence South 87°37' East 3.30 to the middle of Bean Creek Road; thence leaving said southerly line North 01°38'05" East 6.72 feet to the true point of beginning of an easement for maintenance 20 feet in width centered, thence from true point of beginning North 88°21'55" West 18.90 feet; thence South 75°43'36" West 52.55 feet.

Gentlemen:

Permission is hereby granted to the County of Santa Cruz, its contractors and/or authorized agents, to enter and bring the necessary workmen, tools, materials, and equipment onto the property of the undersigned, where shown on the attached map, or where necessary, for the purpose of monitoring Bean Creek while drainage improvements and erosion control measures are constructed on the adjoining property.

It is understood and agreed that the County shall leave the premises in a clean and orderly condition and that any existing improvements located on the Grantor's property that may have been disturbed or removed during the course of the work will be restored or replaced in kind. For the rights herein granted the County of Santa Cruz shall pay the undersigned the sum of \$100.00. The undersigned agree that the County may begin the herein described work on September 11, 2000, prior to receiving payment.

It is further understood and agreed that permission to perform the acts stated herein shall remain in force and effect only until the completion of construction or October 31, 2001, whichever occurs first.
