SUBJECT: COUNTY SERVICE AREA NO. 57, GRAHAM HILL

SUPERVISORIAL DISTRICT 5

Members of the Board:

On March 7, 2001, the Local Agency Formation Commission approved an application to establish Graham Hill County Service Area (CSA) No. 57. The boundary line of the service area encompasses 60 acres and contains one parcel. A 60-lot subdivision of this parcel, known as Graham Hill Estates, Tract No. 1339, has been approved by the Board of Supervisors. As the formation of a CSA was a condition of approval for the subdivision, the property owner within the proposed Graham Hill CSA area is now requesting that your Board take the necessary steps to initiate the formation of a CSA for the purpose of sanitary sewer and drainage system operations and maintenance. Section 25210 of the State Government Code requires that in order to establish a County Service Area your Board must adopt the attached resolution of intention, set a public hearing, and notice this hearing in a newspaper of general circulation.

Once the CSA is established, Public Works will include Graham Hill CSA No. 57 in the 2001/2002 CSA budget and service charge proceeding. At this time sewer and drainage rates for the proposed services are still under consideration and will be submitted for Board action in accordance with Proposition 218, "the right to vote on taxes act." We anticipate finalizing a review of the anticipated budget and rates within the next month.

It is therefore recommended that the Board of Supervisors take the following action:

- 1. Adopt the attached resolution of intention to establish County Service Area No. 57, Graham Hill and setting May 1, 2001, at 9:00 a.m. or thereafter, which is not less than 30 nor more than 60 days after the adoption of the resolution of intention, as the date and time for a public hearing on the proposed County Service Area.
- Direct the Clerk of the Board of Supervisors to publish the resolution of intention as a notice of hearing once in a newspaper of general circulation at least seven days prior to the hearing.
- 3. Direct Public Works to mail a copy of the resolution of intention as notice of the hearing to the property owner within the proposed service area.

RESOLUTION OF INTENTION TO ESTABLISH A COUNTY SERVICE AREA

WHEREAS, pursuant to County Service Area Law (commencing with Section 25210.1 of the Government Code of the State of California), the Local Agency Formation Commission has approved an application to establish Graham Hill County Service Area No. 57 for the purpose of sanitary sewer and drainage system operations and maintenance.

NOW, THEREFORE, BE IT RESOLVED AND ORDERED by the Board of Supervisors that:

- 1. A County Service Area is proposed to be established under the terms of the aforesaid law in the unincorporated area of Santa Cruz County. The boundary lines of the territories proposed for inclusion in the area are indicated in Exhibit "A."
- 2. The name proposed for said County Service Area is Graham Hill, County Service Area No. 57.
- 3. The type of extended County service proposed to be provided in this area is for the purpose of sanitary sewer and drainage system operations and maintenance.
- 4. Sufficient **funds** will be available to pay for such service from service charges collected pursuant to Government Code Section **25210.77a**.
- 5. On May 1, 2001, during the Board of Supervisors morning agenda at 9:00 a.m. or thereafter, a public hearing will be held on the establishment of said County Service Area.
- 6. At such hearing the testimony of all interested persons or taxpayers for or against the establishment of the area, the extent of the area, or the furnishing of specified types of extended services will be heard.


