SUBJECT: VALENCIA CREEK EMBANKMENT REPAIR NOTICE OF COMPLETION

Dear Members of the Board:

After the El Nino storms of the 1998 winter season, a portion of the Valencia Creek embankment began sloughing away at a fairly rapid rate to the extent that the rim of the embankment encroached within 8 feet of the soccer field turf grass at Polo Grounds County Park.. As a result, on September 19, 2000, your Board awarded a contract to The Don Chapin Company, Inc. to repair and stabilize the embankment.

On March 16, 2001, the project was deemed completed after sufficient time had elapsed to monitor the effectiveness of the work. The original bid amount was \$69,730.00 Construction change orders increased construction costs by \$6,950.00, for a total construction cost of \$76,680.00.

This project included the site preparation and construction of a 700 square foot Hilfiker retaining wall along the embankment of Valencia creek which borders Polo Grounds County Park. Change order work included installing erosion control measures including galvanized chain-link fabric over seeded with the Santa Cruz County Erosion Control Mix suited for the project site.

The most recent site observations conclude that the embankment has held up quite well over the winter rainy season, and it appears that the slope has been stabilized now. However, staff will continue to monitor the effectiveness of the embankment stabilization work.


